Why We're Here

More than 350,000 Harris County children do not have access to an after-school program. Kids need safe, stimulating places to go after school, but working parents with extended commutes leave thousands of Houston's young people unsupervised each day. A lack of meaningful adult supervision increases poor grades, truancy, risk-taking behavior and substance abuse.

Who We Are

CASE (the Cooperative for After-School Enrichment) believes that every child deserves a quality afterschool program. Beginning in 1999, with seven sites in Harris County, CASE has grown to support over 70 programs serving more than 10,000 children in 14 districts and 8 charters throughout the Houston area.

In addition to being a member of the national After-School Association and the South East Texas Afterschool Association, CASE is a partner of the Afterschool Alliance's "Afterschool for All" campaign. This national partnership involves over 1,000 regional, state and city organizations, business, elected officials, police chiefs, after-school providers and community leaders.

CASE values Engagement and Enrichment, Safe Environments and Nurturing Relationships, Community and Family, Collaboration and Service, and Choice and Voice.

What We Do

CASE has developed and implemented a variety of programs that serve students, families, schools and communities.

- 21st Century Community Learning Centers: a key component of the No Child Left Behind Act, this program expands academic enrichment for students in low-performing schools. CASE 21st CCLCs sites are located in 39 campuses in 14 school districts and 6 charters.
- Partnership Project: accesses previously unused federal childcare funds to support after-school programs in Harris County public elementary schools. CASE Partnership Project sites are located in 32 campuses in 5 school districts and 2 charters.
- Special Projects: CASE partners with corporations and organizations to enhance learning opportunities and advance the futures of young people.
- Afterschoolzone.org: a clearinghouse that provides information about various after-school, before-school, summer and holiday programs.
- CASE AmeriCorps: trained members of this national service program receive training from CASE to work directly with students in all school grades to deliver CASE Kids' Day curricula, service learning projects and to support the campus after-school program.
- CASE Model Projects: replicable educational models in the areas of the arts, math, science and technology.

How We're Funded

CASE receives funding from a variety of sources and re-grants the money to partners who operate programs across the county. Over the past 10 years, CASE has raised over \$50 million from funding sources that include:

- State: Texas Education Agency, Texas Workforce Commission
- Local: Education Foundation of Harris County, Harris County Department of Education
- Private: Houston Endowment, Frost Bank

CASE 21st Century Community Learning Centers 2011–2012: 13 Participating School Districts, 39 Campuses

The 21st CCLC Program is an opportunity for students and their families to continue to learn new skills and discover new abilities after the school day has ended. The focus of this program is to provide expanded academic enrichment opportunities for children attending low performing schools. Tutorial services and academic enrichment activities are designed to help students meet local and state academic standards in subjects such as reading and math. In addition 21st CCLC programs provide youth development activities, drug and violence prevention programs, technology education programs, art, music and recreation programs, counseling and character education to enhance the academic component of the program.
