REGISTRATION REQUIREMENTS FOR NEW STUDENTS

State Law requires that only a parent or legal guardian can enroll a child in school. The following items are required to register in an HISD school. <u>All original documents must</u> <u>be presented at the time of registration</u>. (Registration requirements are subject to change).

Proof of birth date (original/official copy of Birth Certificate or passport)

Student must be four on or before September 1, 2016 to enter prekindergarten, five on or before September 1, 2016 to enter kindergarten or six on or before September 1, 2016 to enter first grade **Social Security Card** (preferred, but not required)

Proof of Immunizations (must be in English and signed by a physician licensed to practice medicine in the United States.) Immunizations must be complete before a child can be enrolled in school.

Diphtheria and **Tetanus** (total of **Four or Five** immunizations; booster on or after the fourth birthday)

Polio (total of Three or Four immunizations; booster on or after fourth birthday)

MMR (total of **TWO** immunizations on or after first birthday) One dose required for prekindergarten students

Hepatitis B (Three doses)

Varicella (chicken pox) TWO doses on or after the first birthday or a reliable history of the disease. **ONE** dose for prekindergarten students.

Hepatitis A TWO doses required for students in prekindergarten, kindergarten, first, second grades and third grades First dose must be given after first birthday.

Pneumococcal Conjugate Vaccine (PCV7) ONE dose on or after 24 months or a completed series and booster by 23 months required for students between the ages of 24 and 59 months.

Proof of residency in the Bush attendance zone (**TWO original** documents required)

Current utility bill and lease agreement with parent's name and address.

If you lease, one item must be the current lease. Both documents must indicate the parent's name and address. The following documents are considered provisional and will not be accepted during early registration: "Statement of Residence", "Determination of Residency of a Minor" and "Grandparent Care Affidavit". These may be submitted during August registration.

Check out papers and report card from previous school, if applicable.

Parent's or legal guardian's driver's license

All registration documents must be complete before a child is considered "registered". Classroom assignments will not be made until all documents are complete. If a student registers in the spring and is not in attendance on the first day of school, they are not enrolled; and if they do arrive late, we cannot guarantee a place in the classroom.

EARLY REGISTRATION DATES FOR ALL GRADES ARE: MAY 3, MAY 17, AND JUNE 8 FROM 8:00 AM TO 10:00 AM

The first day of school is August 22, 2016
