# • Cell Phone Violation Policy

Current Policy - 1<sup>st</sup> time confiscated, the phone will be taken to the office and the parents will be required to pick it up. 2<sup>nd</sup> time confiscated, the phone will be placed in the June box for the student to pick up at the end of the year.

New Policy  $-1^{st}$  time confiscated, the phone will be sent to the office. The teacher will notify the parent to pick the phone up. At this time, the parent will sign an acknowledgement that they are aware of a \$15.00 administrative fee for the  $2^{nd}$  offense and any subsequent times. Ancillary and lunch aides will notify the teacher if the phone has been confiscated.

If the phone is not picked up within 30 days, the office will no longer be responsible for the phone. Multiple confiscations will result in a discipline referral. Maria Graff made a motion to accept the new policy. It was seconded by Valerie McMaster. All were in favor of accepting the new policy.

• School Uniform Supplier – Parker (requires contract) or Academy Uniform (no contract)

Parker is the sole provider of uniforms for Bush. The school must sign a contract. The BEC decided to go with Academy Uniforms. There is no contract and they offer discounts at certain times of the year. The quality is the same and the location is very convenient.
