# **DISCUSSION:**

- 1. Dave Funk, HISD Facilities Planner introduced himself and his role within HISD and the project.
- 2. Sam Swart and Sherry Hill of Hill, Swart Chu Architects LLC were introduced as the architects for the project. The PAT was very pleased at the selection as these were the architects they wanted.



- 3. Mr. Funk reviewed the PAT's Guiding Principles, facilitated discussion and provided direction to the group for what the Guiding Principles should address.
- 4. Most of the meeting was used to thoroughly review and develop the Guiding Principles.
- 5. It was discussed that the PAT wanted the school to have large and open classrooms to facilitate a Montessori environment.
- 6. PAT members voiced that they wanted to minimize the demolition of the trees and the natural environment that surrounds the school. Nature is a fundamental principle for the school.
- 7. There was a general consensus that natural colors and materials should be used. One PAT member said that bright colors could be a distraction to the students and that they want the focus to be more on the actual curriculum in the classroom rather than the appearance of the classroom.
- 8. There was a recent incident of privacy invasion in a classroom that was being used as a changing room. This was a driving factor behind the group wanting secure locker rooms for students to use while changing clothes.
- 9. A large emphasis for the Guiding Principles as a whole was to have a safe learning environment and a facility that specifically supports Montessori style of teaching. A copy of the approved Guiding Principles is attached.
