    - i. PAT questions this strategy; believes this is not possible due to the school's current usage of the spaces in the S.O.C
    - ii. PAT There are at least 25 classrooms in the S.O.C building. There is no room in any of the other school buildings where the displaced classrooms could be relocated. This would make the school non-functional.
    - iii. PAT-Requests more integration and information from HISD
    - iv. PAT Would like to inquire about building school on other site
    - v. Need to find out about parking variance with Texas Southern University
    - vi. Get information about moving existing mechanical yard and installing a temporary mechanical yard
    - vii. PAT would like to not be in temporary buildings
    - viii. PAT Students temporarily relocating to other schools is not an option
    - ix. Can building occupancy increase? (Currently 70%)
    - x. Discussion of first demolishing portion S.O.C building at north fire wall and installing temporary parking on existing tennis and basketball courts and/or in front of school on existing west lawn.
