## "Expression of Emotion: Movement & Art"

Works on paper, including photography are permitted, with a maximum size of 16" x 20" UNMATTED. Please include the following information on the back of each artwork: TITLE, STUDENT'S NAME, TELEPHONE NUMBER, SCHOOL, GRADE & TEACHER'S NAME, TELEPHONE NUMBER & EMAIL ADDRESS.

SPA works collaboratively with Texas Children's Hospital (TCH) to provide a venue for display of selected art contest entries. All SPA art contest entries have an opportunity of being selected to be part of the Texas Children's Hospital permanent collection. *Entries do not have to be award winners to qualify for this opportunity.*

### ART CONTEST PRIZES

Senior contest winners will be awarded scholarships ranging from \$500 to \$1,000 and winners in grades K-11 will receive savings bonds ranging from \$50 to \$500. All first, second and third place winners will receive a family membership to the Museum of Fine Arts, Houston. First place winners for grades K-11 will receive a scholarship to the Glassell Junior School, MFAH. All winners of the various categories and fifteen honorable mentions will receive a special gift from Utrecht Art Supply and tickets to Alvin Ailey American Dance Theater provided by Society for the Performing Arts.
