#### Please make note of the information listed below:

- Outstanding balances: Registrations cannot be accepted from anyone who has an outstanding balance from any previous semester or school year. Any outstanding balances will result in retaining the student's report card or records. Failure to meet your financial obligations on time will result in suspensions of our services to your child immediately.
- Remember, registrations, payments, and/ or late payments need to be submitted in the form of <u>MONEY ORDER or CASHIER'S CHECK</u> at all times payable to The Rice School.

<u>Registrations and payments are processed in 24 hours as they are received</u>. Please be aware that since our applications take 24 hours to process, any registrations and payments received the same day will not allow your child to participate in the Rice School Early Risers or Afterschool Program that same day. Therefore, your child will be able to participate in the Early Risers or ASP program the following day after your application has been processed. You will be responsible for making transportation arrangements with your child's teacher. If no alternate form of transportation is determined, your child will be sent to late carpool, where a late pick-up fee will be assessed. Applications that are submitted without payment will not be processed. We serve our customers on a first come, first served basis. Once maximum capacity is reached for each grade level, no more applications will be accepted.

#### The Rice School Early Risers & After School Program Fall 2021 Enrollment Regulations

**REGISTRATION –** I understand that registrations are for the **Fall 2021 semester**. The **registration deadline is on June 14<sup>th</sup>, 2021.** No other applications will be accepted after August 23<sup>rd</sup>, 2021. No refunds are issued in the event that your child is withdrawn from the Early Risers or After School Program before the semester ends. If you request cancellation of services, please email the Director, Elexis Ortuno, at <u>Elexis.Ortuno@houstonisd.org</u>. If no communication is made to the director of cancellation of services, your outstanding balance will remain on file.

(No refunds, credits, or account changes/ transfers will be issued after August 23<sup>rd</sup>, 2021).

CANCELLATIONS HISD – In the event HISD CANCELS all after school activities for inclement weather or other circumstances, there will be NO AFTER SCHOOL services provided. You will need to pick your children up by 4:00 pm since the school will be closed and there will be no staff to supervise your children. No refunds will be issued.

LATE PICK- UP FEES – I understand that if I have a child enrolled as a Full-Time 4:00PM-6:00PM participant, and if I pick up my child after 6:00 PM, I will be automatically charged a late fee. If my child is enrolled as a Half-Time 4:00-5:00PM participant, I will be automatically charged a late fee if my child is picked up after 5:00 PM. Late fees must be paid in 24 hours by money order or cashier's check made out to The Rice School. (Please refer to late- pick up fee chart for details on pricing). Initials:

DISMISSAL/PICK UP- In order for my child to be dismissed from the After - School Program, I must show a photo ID at the front attendance window when signing them out. My child can only be released to the authorized parties I have listed on the emergency contacts/permission to pick up form. If I must send an unauthorized person to pick up my child, I must e-mail the coordinator 24- hours prior with all the information on the person picking up. I will inform the person I am sending to have their photo ID ready when signing my child out. I will also e-mail the coordinator of any changes in my child's pick - up schedule for that day.

SPECIALTY CLASSES- Students participating in any specialty classes must be registered with The Rice School After School Program.

PAYMENT PLANS AND REGISTRATIONS – I must submit all payments to The Rice School in the form of a money order or cashier's check in a timely manner according to the payment dates (Registrations payment #1 due June 14<sup>th</sup>; 2<sup>nd</sup> payment September 10<sup>th</sup>, 3<sup>rd</sup> Payment October 15<sup>th</sup>, 4<sup>th</sup> & Final Payment November 19<sup>th</sup>). I will be charged a \$20.00 late fee if payments are not received by due dates. I understand that any unpaid fees will result in my child's report card being retained and I will not be able to register with either the Early Risers or After School Program in the Spring 2022 semester.
