Failure to meet your financial obligations on time will result in suspensions of our services to your child immediately.
- Remember, registrations, payments, and/ or late payments need to be submitted in the form
 of <u>MONEY ORDER and CASHIER'S CHECK</u> payable to The Rice School or through
 SCHOOLPAY.

Registrations and payments are processed in 24 hours as they are received. Please be aware that since our applications take 24 hours to process, any registrations and payments received the same day will not allow your child to participate in the Rice School Early Risers or Afterschool Program that same day. Therefore, your child will be able to participate in the Early Risers or ASP program the following day after your application has been processed. You will be responsible for making transportation arrangements with your child's teacher. If no alternate form of transportation is determined, your child will be sent to late carpool, where a late pick-up fee will be assessed. Applications that are submitted without payment will not be processed. We serve our customers on a first come, first served basis.
