Therefore, your child will be able to participate in the Early Risers or ASP program the following day after your application has been processed. You will be responsible for making transportation arrangements with your child's teacher. If no alternate form of transportation is determined, your child will be sent to late carpool, where a late pick-up fee will be assessed.
