Charter Schools and Title I-Funded Purchases

Unlike traditional HISD schools, HISD's charter schools will be able to use their Title I funds to purchase desktops, electronic notebooks, Hotspots, laptops, and charging carts.

This is because charter schools are not receiving these items directly from the district for the 2020-2021 academic school year.

ESSA Consolidated Grant Application – New Requests (2020-2021)

Capital Outlay -

The deadline (of December 4, 2020) for campuses to <u>request</u> capital outlay for the 20/21 SY has passed. **The deadline to** <u>*purchase* **TEA approved capital outlay, campus library books, and technology is Friday March 5, 2021.** This purchasing deadline applies to both Title IA-Schoolwide funds and Title IA-Comprehensive funds. All newly purchased capital outlay and technology are required to receive a tag from the Fixed Assets Accounting Department (Property Management).</u>

All new requests for TEA approved capital outlay, campus library books, and technology will be included in the 21/22 ESSA Application in June 2021. A memo will post in April 2021 with information regarding how to make a campus request.

All capital outlay requires prior TEA approval. Capital outlay includes technology such as electronic notebooks and tablets, electronic charging towers, docking stations, graphic calculators, and interactive whiteboards etc.

Capital outlay items - regardless of the cost - have the following in common:

- They have a useful life of one or more years, and
- They are tangible, non-expendable in nature.

REMINDER: New requests may not be purchased until the district receives the Notice of Grant Award (NOGA).

Out-of-State Travel (January 1, 2021 — June 30, 2021)

Out-of-state travel costs are allowable and always require specific TEA approval. Additionally, out-of-state travel is not allowed where the same type and quality of training is available in-state. Each out-of-state travel request requires a written justification form which must be approved by TEA prior to the trip occurring.

NOTE: The district has made the decision that employee requests for out-of-state travel will continue to be denied, tentatively through 06/30/2021, because of the increased numbers of positive COVID-19 cases in the area. For campuses that had had travel requests approved by TEA in the ESSA Application, that travel has been suspended because of the mandate.



Virtual PD

HISD allows the use of TIA funds for virtual/out-of-state PD.

All campuses must follow the previous guidance for having out-of-state travel approved and must adhere to the limit of 5 attendees. TEA's guidance specifies that districts should be using the train-the-trainer model for PDs.

A memo will post on January 18, 2021 with upcoming information regarding out-of-state travel requests.

Academic Boot Camp (ABC)

HISD has set up designated district-wide Academic Boot Camp (ABC) days to support student development (See December 2020 & March 2021 schedule below).

Scholarships Available in 2021

2021 scholarships are being offered by the National Association of Federal Education Program Administrators (NAFEPA) and the Association for Compensatory Educators of Texas (ACET).

NAFEPA is offering four scholarships for qualifying high school seniors attending their first year of college. <u>Click here</u> for more information. The deadline to apply is **January 11, 2021**.

ACET offers two categories of scholarships geared toward:

- Graduating high school students who have participated in a compensatory education program sometime during their school career, and
- Adult paraprofessionals currently working with a school district in a compensatory program. <u>Click here</u> for more information. The deadline to apply is **February 5, 2021**.

Translating Your School Improvement Plan (SIP)

The <u>entire</u> SIP – including the Executive Summary – must be translated.

As campuses seem to be experiencing challenges in translating this document, here are options that may help in completing this task:

- Access the <u>Purchasing Department</u> site and use key word **Translation** in the Search tool to display a current list of approved vendors (or call the department at **713-556-6515**).
 - The campus should receive at least two quotes for translating the document.
 - General Funds as well as Title I Funds can be used to pay for this contracted service.
- Enlist the services of campus staff skilled in the needed language(s) and familiar with the academic verbiage.
- Use "Google Translate" -- But you MUST have the document reviewed by professional staff members who are fluent in the language(s) to ensure that the vocabulary represents the content accurately.

Best Practices

Catching Up on Parent Notifications

If you were unable to send out Parent Notification letters by the 2020 deadlines, be sure to catch up this month. All parent notifications – as well as the PFE Policy and School-Parent Compact – should be distributed no later than **Monday, January 11, 2021**.

The required notifications are listed below:

- Title I Status Notification Letter
- Teacher Certification (Right to Know) Notification
- Explanation of HISD Curriculum
- Explanation and Description of Assessments

Additional required Title I documents to be

- Parent and Family Engagement Policy
- School-Parent Compact

(Both of the above documents must have been developed/revised with parents – as evidenced by an agenda, attendance document, and feedback.)

Virtual Field Lessons

HISD allows field lessons to be paid with TIA funds but face-to-face field lessons will not be approved for the spring semester, because of the rising numbers of COVID-19 cases in the area.

Campuses may use Title I funds for <u>Virtual</u> Field Lessons (if there is a cost). All campuses must follow the previous guidance for having field lessons approved and adhere to the <u>APPROVED FIELD LESSON LIST</u>. Many facilities on the approved list will now be offering virtual field lessons. You will need to confirm with the site, as to whether virtual field lessons are an option and the cost.

For field lessons not on the approved list, contact your School Grants Administrator for guidance.
