- Use of this equipment for any purpose other than educational use may result in loss of privileges. 0
- The district does not permit unethical use of the Internet, email, or any other media. Violation of this policy may 0 result in the loss of laptop loan privileges and disciplinary action by the school.
- The configuration of the hardware equipment and all accompanying software may not be altered, nor can 0 software be copied to or from the computer or installed on the computer under any circumstances.
- Parents/guardians are required to pay a cash, non-refundable security deposit of \$25. The payment must be 0 made prior to the student receiving the laptop.
- Parent/guardians accept financial responsibility for cost related to damage due to purposeful action or gross 0 negligence. The district will proceed with legal action, should financial obligation be ignored. For more information, refer to care of instructional materials in student manual.
- The district will provide a padded laptop bag, which fits inside any backpack. The laptop MUST be kept inside the 0 case at all times, securely strapped at all times when not in use.
 - FAILURE TO KEEP THE LAPTOP IN THE CASE WILL VOID THE INSURANCE, WHICH WILL DEEM THE PARENT/GUARDIAN FINANCIALLY RESPONSIBLE FOR REPAIRS OR REPLACEMENT.
 - Students found with laptops outside the district-issued case will be referred for disciplinary action. 0 Recurrent incidents will result in forfeiture of the laptop.
- The student assumes personal responsibility for the laptop. If left unattended for any reason under any 0 circumstances, and collected by school personnel, the student is responsible for payment of a \$5 fee.
- The laptop, which is the property of Houston ISD, must be returned prior to the end of the 2022-2023. school 0 year, or in the event of school change or early withdrawal.
- The district has provided students with a "Digital Citizenship Orientation" and information for parents, via Open 0 House events and handouts, including information about how to care for the device and how to make responsible use of technology.
