School Responsibilities

Fleming Middle School will:

- 1. Provide high quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:
 - a. Provide daily high quality instruction centered on a learning objective aligned to the TEKS and assessed by a demonstration of learning
 - b. Ensure opportunities for additional support throughout the school day via the implementation of the LSAE model and enrichment opportunities within the Teams Center
 - c. Assess student learning every three weeks via mid-cycle and cycle assessments aligned to key learning standards
 - d. Measure student learning aligned to national norms via the MAP Growth assessment for Math, English, and Science to ensure adequate growth and student achievement throughout the year
- 2. Hold parent-teacher conferences during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:
 - a. During scheduled daily grade level PLC time
 - b. Before or after school (by appointment)
 - c. During Open House and Parent Teacher Night
- 3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:
 - a. Mid-cycle progress reports and end of cycle report cards (every 3 weeks)
 - b. Ongoing grade access via Powerschool
 - c. Parent updates for students at risk of failures via teacher calls and notices, especially for at risk populations (SPED, EB, etc...)
- 4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:
 - a. School email address / phone number (allow 24 hour response time)

- b. Classroom Remind accounts
- c. Parent Teacher Conferences (by appointment only)
- d. During special events like Open House, Meet the Teacher Night, etc...
- 5. Provide parents opportunities to volunteer and participate in their child's class and to observe classroom activities as follows:
 - a. Classroom observations (by appointment only)
 - b. School events (programs, dances, etc...)
 - c. PTO
