2017-2018 Parent Involvement Policy

General Expectations

If students are to be successful, their parents or guardians must be actively involved in their education. 5. If the school-wide program plan is not satisfactory to the parents of participating Children, the school will submit parents' comments on the plan to the Department of External funding and revise the plan as advised by the HISD Title I, Part a Parental Involvement Program Administrator and other District designees as advised.

6. SHARED RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT
