- Board Goals:
 - Goal 1: The percentage of 3rd grade students performing at or above grade level in reading as measured by the Meets Grade Level Standard on STAAR will increase 8 percentage points from 42% in spring 2019 to 50% in spring 2024.
 - Goal 2: The percentage of 3rd grade students performing at or above grade level in math as measured by the Meets Grade Level Standard on STAAR will increase 8 percentage points from 46% in spring 2019 to 54% in spring 2024.
- Roberts 2018 2019 for All Students (the goal is set to keep our current progress in mind)
 - Meets level reading 76%
 - Meets level math 82%

Budget Reconciliation

- Enrollment Projection for 2020 -2021 742 (20-21 student enrollment projection)
- Enrollment on October 30 687 (-55 students from our projection) (20-21 current enrollment)
- Loss in funding \$227, 426 comes out of our school budget
- We currently have \$114,000 in holding, the district budget was not allocated all at once for this year
- Total remaining in total budget for the school year \$53, 405 with closing two additional positions which our campus could run on but would require us to make significant changes in spending.
- Position cuts no positions being cut that are currently filled.
- The district is replacing most of the laptops that have been distributed to students for virtual learning so we will not need to take on this added expense.
- Most of the money in the budget will go to covering substitutes.

Safety

- Monthly drills will continue
- Intruder drill has not been done yet we normally wait to do this later but will do before we go home for the winter break, parents will also be informed after the drill as well.
- Parking lot gates and perimeter gates waiting on PO approval for the gates to be fixed

Questions/Concerns

• Committee Member: Are the goals for the SIP too ambitious? Epps Response: No, we want to stretch but also need to remember that students will have deficits from last year, our focus is how to support kids this year and stretch them to the goal.

- Committee Member: Is there a big difference between the snapshots this year and last year? Epps Response: Yes, there are things missed because kids have been out of school for a bit, there also was no penalty for students who did not participate online in the fall.
- Committee Member: What is the approximate percentage of students who are not logging in now? Epps: About 15% (this is an approximate number) currently of those who are virtual, we are still sending reminders for assignments and asking students to turn in assignments and making contact with the parents.
- Committee Member: If we do not have STAAR would we be missing data points? Epps: Yes and No, we have many other data points to look at that would give us good information for our students but STAAR does provide us comprehensive data for students in grades 3rd – 5th.
- Committee Member: Are we returning after Thanksgiving? Epps: Yes, we have been told we will be back in person.
- Committee Member: Has there been more discussion about how testing for COVID will be utilized? Epps: The nurse and I have both attended a meeting on what the process might involve, but we have not received next steps. HISD has not started testing on campuses as of yet.
