Meeting was called to order at 3:30 pm.

3. 22-23 SIP Review

- The Committee reviewed the Board Goals for the 22-23 school year:
 - Board Goal 1: The percentage of 3rd grade students performing at or above grade level in reading as measured by the Meets Grade Level Standard on STAAR will increase.
 - By the end of the 22-23 SY, 98% of all students tested will score at the Meets level, and 83% of all students will score at the Masters level as measured by STAAR reading.
 - 90% of grades 1st-5th Tier 1 students as determined by Ren360 BOY reading will remain on Tier 1 REN360 by the EOY assessment window.
 - Board Goal 2: The percentage of 3rd grade students performing at or above grade level in math as measured by the Meets Grade Level Standard on STAAR will increase.

- By the end of the 22-23 SY, 87% of all students tested will score at the Meets level, and 70% of all students will score at the Masters level as measured by STAAR math.
- Board Goal 3: The percentage of graduates meet the criteria for College/Career/Military Readiness as measured in Domain 1 of the state accountability system will increase.
 - By the end of the 22-23 SY, the number of African American and Hispanic students scoring at the Masters level in reading will increase from 49% to 55% and the Masters level in math will increase from 50% to 56% as measured by STAAR.
- Board Goal 4: The percentage of students receiving special education services reading at or above grade level as measured by the Meets Grade Level Standard on the STAAR 3-8 Reading and STAAR EOC English I and II assessments will increase.
 - By the end of the 22-23 SY, 67% of all Special Education students tested will score at the Meets Level in reading as measured by STAAR.
- Additional Campus goals:
 - The average daily attendance rate will remain at 98% as measured by TEA.
 - The number of out-of-school suspensions will remain at zero for the 22-23 SY as defined by TEA/HISD guidelines.
 - By the end of the 22-23 SY all students will engage in at least two internet safety programs and one inclusive program.
 - By the end of the 22-23 SY, 68% of all students tested who receive Special Education services will score at the Meets level in math as measured by STAAR.
 - By the end of the 22-23 SY, at least 70% of all Emergent Bilingual students will make one year's growth as measured by TELPAS.
- The Committee did not have questions nor concerns and all was in agreement with the SIP goals.

4. School Safety

- Door checks
 - It is a TEA requirement that all classroom doors must be locked at all times and cannot propped open. The campus is required to do weekly exterior door checks. The Roberts Admin team will conduct a random daily door check.
- Water Oak tree removal
 - HISD personnel has come out to inspect the tree by Ms. Goldsmith's old classroom and also the tree by the 5th grade deck. The front area will

remain blocked off until HISD comes to remove the tree. Please advise any student or parents to move away from the area.

- New safety concerns
 - Ms. Kyle shared that the right red door at the end of the 1st grade hall way does not close all the way. Ms. Epps stated that the work order has been called in.
 - Mr. Vuong asked if the Gaga Pit was still off limits because the caution tape is no longer there. Ms. Epps response is that the Gaga Pit is still off limit and will call in a work order for it.
 - Ms. Salas shared that the glass doors going out to the 3rd grade t-building does not close properly. Ms. Epps stated that the work order has been called in.
 - Ms. Kyle also shared that one of the stalls in the girls rest room by the café still has a broken door and Ms. Epps stated that the work order has been called in.
