### **SDMC Meeting Minutes**

May 11, 2017

- I. Standards for School Attire at Roberts
  - a. Committee reviewed "Standards for Good Grooming" from TH Rogers as an example of expectations for proper school attire from another campus.
  - b. SDMC reviewed and discussed preferred parameters.
    - Closed toe shoes- Committee members suggest that closed toed shoes are included as an expectation for everyday attire.
    - Tops/Shirts- Committee agreed on expectation of no halter tops, tank tops, spaghetti straps, sleeveless jerseys (without undershirt), and tops that expose the midriff or back.
    - Bottoms/shorts, pants, skirts, and dresses- Committee discussed not permitting cut off clothes, compression shorts or pants, sagging pants. Also, it was suggested that clarification of "leggings may be worn only under a shirt, dress, or loose-fitting top cover bottom" be included. Committee agreed on expectations that bottoms must be finger-tip length, shorts must be worn under skirts or dresses, and loose fitting pants must be worn with a belt.
    - Accessories- Committee members discussed accessories acceptable for outside use including hats, caps, and head coverings. These are permitted with restrictions.
  - c. Dress code policy will be in place for the 2017-2018 school year.

- II. Safety Patrols for 2017-2018
  - a. Requests for student Safety Patrols. As Safety Patrols, students are encouraged to take leadership and promote safety.
  - b. Committee members discussed need for helping with supervising during morning arrival inside and outside of the building.
  - c. Students will be recommended for Safety Patrols.
  - d. Committee members agreed that this would be supported.
  - e. Students in 4<sup>th</sup> and 5<sup>th</sup> grade could be included for the Fall and Spring semester.

# III. Proposed Budget for 2017-2018

- a. Budget has been approved for the 2017-2018 school year.
- b. The district has not provided information about how Recapture or new programs will impact our budget.
- c. Ms. Epps has asked PTO for a reserve to help pay for needed General Supplies.
- d. District has not released if schools we be able to continue Carry-Over funding.
