#### AP Spanish Syllabus Fall/Spring 2024- 2025

#### **COURSE OVERVIEW \***

The AP Spanish Language and Culture course is a rigorous course taught **exclusively in Spanish** that requires students to improve their proficiency across the three modes of communication (interpersonal, interpretive, and presentational).

The course focuses on the integration of authentic resources including online print, audio, and audiovisual resources, as well as traditional print resources that include literature, essays, and magazine and newspaper articles with the goal of providing a rich, diverse learning experience.

The AP Spanish course provides willing and academically prepared students with the opportunity to earn college credit and/or advanced placement and, most importantly, to achieve advanced fluency in Spanish, which will result in great advantages not only academically, but professionally in the increasingly competitive job market.

By taking an AP course, students also demonstrate to college admission officers their abilities to perform successfully on rigorous college courses.

The AP Spanish course concludes with a college-level assessment (**on May 15th, 2025, at 8 a.m.**). Most four-year colleges and universities in the United States and universities in 60 countries recognize AP in the admission process and grant students credit placement or both based on successful AP Exam scores (visit **www.collegeboard.org/apcreditpolicy** to view AP credit and placement policies at more than 1,000 colleges and universities).

Scoring a 3 or higher on an AP Spanish Exam means more than just the successful completion of a course; it is a gateway to success in college.

**IMPORTANT:** The AP Spanish course <u>is not intended to focus on teaching grammar concepts</u>. Students enrolled in the AP Spanish course are expected to show mastery of concepts covered in levels 1, 2, and 3.

#### **Grading Plan**

Extra credit <u>is not</u> offered in this class

- The teacher will submit grades every week on the student's gradebook in <u>HISD Connect</u> <u>by PowerSchool</u>. This information is available 24/7. Students and parents are encouraged to monitor grades at least once a week and notify the teacher of any errors if found.
- Students will ask questions about their assignments DURING school hours (preferably during the class period) to make sure the teacher can assist them before an assignment's deadline.
- Questions asked during non-school hours will likely be answered on the next school day.
- Students MUST report any problem in completing an assignment <u>before the deadline</u>; otherwise, the assignment will be considered late.
- Students will contact the teacher at <u>LLEON1@houstonisd.org</u>.

#### Late Work Policy and Make-Up Policy

- The student should complete assignments/assessments by the due date. Late assignments are graded based on a scale of 70 points unless due to an excused absence.
- A missed assignment or assessment must be completed within 3 school days; otherwise, the grade will be zero.
- A student who has been unable to complete assignments/assessments due to <u>an excused absence</u> (i.e.: illness or other special circumstances as determined by DeBakey HSHP policy) should complete them within three school days counted <u>from the day the student has returned to school.</u> After 3 school days, the grade will be zero.
- If absent, a student is responsible to find out what work needs to be completed by checking the Spanish class page in Canvas.
- If a student is unable to access the Spanish class's webpage or has problems while completing an assignment; he/she should notify the teacher at <u>LLEON1@houstonisd.org</u> or during class. The student MUST report any problem before the deadline has passed; otherwise, the assignment will be considered late.

#### **Cheating Policy**

Cheating is academic dishonesty. Students found to have engaged in academic dishonesty shall be subject to disciplinary penalties and grade penalties on assignments or tests. Academic dishonesty includes copying the work of another student, allowing work to be copied, writing notes on desk tops or other surfaces, using cell phones during examinations, taking pictures of assessments and/or sharing with others, plagiarism, unauthorized communication between students during an examination, making untrue statements or giving misleading information or impressions, and any other situation that involves students attempting to mislead or acquire information to gain academic advantage.

#### **Cell Phones and Electronic Devices**

Cell phones, personal devices, headphones, and earbuds are not to be out, visible, nor used during class time and during transitions between classes. Cell phones are not to be used during class time unless the teacher has specifically allowed it for instructional purposes. In addition to disciplinary action, the unauthorized use of electronic devices may result in confiscation. A \$15 administrative fee payable to HISD will be charged if the device is claimed within the 30 days. Devices not claimed will be sent to Property Management for disposal. As of publication, students may only use cell phones during the lunch period when on campus.

IMPORTANT: If a student uses a phone during testing, the consequences for cheating will apply. Students who possess cell phones during state and national testing will have their exams voided.

#### **Retake Policy**

- If a student receives a failing grade on a test, he/she may request a retake for a maximum average of 70 points.
- The retake grade will be calculated by averaging the grades of the first and second tests. If such an average is higher than 70, the final grade will automatically default to 70.
- Quizzes <u>are not</u> eligible for retakes.
- Common Assessments or Final Exams <u>are not</u> eligible for retakes.
- The retake must be completed within 5 school days after the results of the first test have been communicated to the student or on the day and time indicated by the teacher.
- Retake opportunities should only be scheduled <u>outside of regular class time.</u>

#### Tutorials (by appointment only)

- Tuesdays afternoon (3:35 p. m. 4:30 p. m.). At the teacher's discretion, tutorial days may be changed throughout the year. The teacher will notify students when it happens.
