On August 25, 2014 HISD opened two Middle College High Schools in partnership with Houston Community College:

- MCHS at HCC Gulfton

 Serves the community of Southwest/Northwest Houston
- MCHS at HCC Felix Fraga Serves the community of Southeast/Northeast Houston

Middle College High School is an HISD high school and is in partnership with Houston Community College. Our mission is all students will obtain their high school diploma in a supportive, flexible academic environment, while building habits and skills to help them be successful in any post-secondary academic institution or the workforce. Our school is perfect for students looking for a non-traditional school schedule that offers support in a safe and collegial environment.

Middle College has three primary populations.

- First, MCHS at Fraga is also for students needing a small environment because the traditional high school setting is/was not an effective model.
- Secondly, we serve students that are on track to graduate but have a life circumstance that limits their ability to thrive in the traditional high school and an earlier transition to college would be beneficial.
- Finally, we seek to support underserved students that have historically limited access to higher education and without additional support may never transition to college.

Middle College HS at HCC Felix Fraga is committed to the education of children in the community. The Faculty, staff and parents will share the responsibility for improved student academic achievement. The school will work to ensure that the required parental involvement meets the requirements of section 1118 (The Elementary and Secondary Education Parental Involvement Policy (ESEA Parental Involvement Policy).

 District mandated assessment measures such as REN 360 (BOY, MOY, EOY), TELPAS, DLA's, Content
 benchmarks, Common assessments, SAT/PSAT.

- Students' STAAR/EOC exam results are sent home for parents to review.
- Title 1 Parent Advisory Committee (PAC) meetings respond to parent suggestions.

Shared Responsibilities for High Student Academic Achievement

A school- parent compact was initially developed in 2014, at a Parent Advisory Committee (PAC) meeting. This school-Parent Compact has been reviewed and/or revised annually by the PAC. Building Capacity for Involvement

Middle College HS at HCC Felix Fraga will build the schools' and parents'/guardians' capacity for strong parental involvement to ensure effective involvement pf parents and to support a partnership among the school, parents/guardians, and the community to improve student academic achievement. It is part of MCHS at HCC Felix Fraga to parents/guardians in strategies focusing on how to help their children learn.

- 1. One way this is done is through the explanation of education laws. Parents/guardians are provided with information about Houston ISD, state, and national education goals, Title 1 requirements, STAAR, the School Improvement Plan and PAC Meetings. Bilingual communication in English and Spanish is always provided.
- 2. Additionally, parents/guardian educational sessions are help where presentations are designed to help parents/guardians know how to access student progress information from Parent/student-Connect, how parents/guardians can work with educators to help their student, and how to be involved in the decision making about the education of their children.
- 3. Ongoing training is also provided to MCHS at HCC Felix Fraga teachers and other staff members. These professional development sessions communicate to school staff the importance of involving parents, the role of parents as partners, programs available for parents, and methods for building ties between

home and school. PAC members periodically participate in these sessions to underscore the importance of parental involvement.

MCHS at HCC Felix Fraga strives to coordinate parental involvement activities among the different programs available on our campus. Shared parental involvement activities are sponsored for Title 1 Part A, PAC, and MCHS at HCC Felix Fraga.

Communication about Student Learning

Participation and involvement of all parents is important to MCHS at HCC Felix Fraga. Home visits are conducted by designated staff members from MCHS at HCC Felix Fraga under certain circumstances. If it is impossible for a parent/guardian to come to the school due to illness or injury, and they request a face-to-face meeting, a home visit may be arranged. Also, if no valid telephone number for contact has been provided a home visit will occur, if necessary, to contact and inform a parent/guardian. Additionally, we ensure that parents/guardians with disabilities have the opportunity to participate in all activities by providing handicap access to all areas of MCHS at HCC Felix Fraga.
