**Parent Involvement Policy
2022-2023**

Eastwood Academy is committed to the education of the children in our community. We feel parental involvement is an essential piece in ensuring that our students are successful in school. We believe that when parents are more involved in the academic process, school becomes more of a priority for their children (whether in person or virtual).

Title I regulations require that each school served under Title I jointly develop with and distribute to parents of participating children, a written parental involvement policy agreed on by the parents that describes the requirements outlined in Title I law.

A. POLICY INVOLVEMENT

1. Convene an annual meeting, at a convenient time, to which all parents of participating children shall be invited and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved.

Our school holds an official State of the School Address by the end of September each school year to review with parents Title I School requirements and the school's Parental Involvement Policy. In addition, the principal gives parents an update on test data, adequate yearly progress status, and facilitate a review of the school's improvement plan.

2. Offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, childcare, or home visits, as such services relate to parental involvement.

Parents are invited to participate in a variety of meetings and activities over the course of the school year. An Open House is held in September to provide parents the opportunity to formally visit their child's classroom to become better informed about grade level expectations and their student's academic progress. The contents of our school's parent resource center are advertised frequently throughout the school year to highlight the various books and pamphlets, for home use or on-campus resource.

Due to the hectic and varying schedules of our school family, effort will be made to provide training opportunities to parents via links on our school website making information accessible twenty-four hours a day.

Parents will be invited to participate in a parent-teacher conference at least twice a year to discuss their child's progress. Teachers may receive parents in the morning, during the school day and/or after school to accommodate as many reciprocating parents as possible.

Eastwood Academy will offer 4 primary meeting each offered twice once in the morning and the other during the evening on opposing days.

3. Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under this part, including planning, review, and improvement of the school parental involvement policy.

Our school annually invites parents to participate in review and revision meetings to examine and discuss our School Improvement Plan and Parent Involvement Policy. The school's parent council consistently reviews school policy in an organized, ongoing, and timely way. An organized PTA has been established in our school to create a forum for parental input and involvement. Our PTA affiliation connects our school to parental involvement resources at the state and national level.

4. Provide parents of participating children timely information about programs under this part; descriptions and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress and the proficiency levels students are expected to meet; and if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any suggestions as soon as practically possible.

Our school communicates with parents often the state's curriculum and assessment expectations, school-wide requirements in relation to the delivery of instruction, the techniques utilized to evaluate student work, an individual classroom rituals and routines pertinent to the academic success of our students. We use a variety of communicative techniques such as our School Handbook, School newsletters, School website, classroom websites, School Messenger (phone call system), Parent/Teacher Conferences, SST Meeting, IEP Meetings, PTA meetings, school council meetings, individual notes/calls home, family fun nights, surveys (paper and phone), parent resource room, parent workshops, open house, back to school night, midterm progress reports, report cards, Benchmark results, fluency scores, etc. to solicit parent participation and deliver important information in hopes of creating productive dialogue between home and school concerning improved student achievement.

B. SHARED RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT

As a component of the school-level parental involvement policy, each school shall jointly develop with parents for all children served under this part a school-parent compact that outline how parents, the entire school staff, the students will share the responsibility for improved student academic achievement.

The education of a student is not only the responsibility of the teacher, but also of the parent and the child.

C. BUILDING CAPACITY FOR INVOLVEMENT

To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, each school and local educational agency assisted under this part.

Faculty and staff members will be cognizant of educational research on Parental involvement. Parental input will be solicited throughout the year in meetings, through surveys and during one-on-one conferences. Information derived will be utilized by the school's administrative team to strengthen the tie between school and home for the purpose of increasing student achievement.

4. Shall, to the extent feasible inappropriate, coordinate and integrate parent involvement programs and activities with community Based learning programs and conduct other activities, such as counseling, tutorial and field trip experiences that encourage and support parents in more fully participating in the education of their children.

5. Shall ensure that information related to school and parent programs, meetings and other activities is sent to the parents of participating children in a format and, to extend practicable, in a language parents can understand.

Due to the volume of paper that is sent home each year from school to home, written information is purposefully as compact and concise as possible. Eastwood Academy has made it a practice to send home school correspondences in English and Spanish to ensure all information related to our school is understandable. A system translator assists our school with oral communication when necessary.

D. In carrying out the parental involvement requirements of this part, district, and schools, to the extent practicable, shall provide full opportunities for the participation of parents

with children with limited English proficiency, parents with children with disabilities, and parents of migratory children, including providing information and school reports in a format and, to the extent practicable, in a language such parents can understand.

Parents of all students, regardless of English proficiency, mobility, or disability, are an important part of our Learning Community. All parents are afforded the opportunity to be involved in their child's school environment. For this reason, if a special need is identified that would help a parent to understand the educational process and the academic progress of his/her child more fully, assistance will be provided for that parent. This type of support often comes in the form of interpreted school documents in a parent's primary language, having an interpreter on hand to translate important information at school wide meetings and events, working with an interpreter to provide translation in parent/teacher conferences, making available parent resource in our Center that are in English and Spanish, participating in faculty and staff training to better understand the culture of the students served, providing easier accessibility to parents and/or students with disabilities, etc.

Politica de participaci6n de los padres

Eastwood Academy esta comprometida con la educacion de los nifios de nuestra comunidad. Creemos que la participacion de los padres es una pieza esencial para garantizar que nuestros estudiantes tengan exito en la escuela. Creemos que cuando los padres se involucran mas en el proceso academico, la escuela se convierte en una prioridad para sus hijos (ya sea en persona o virtual).

Las regulaciones del Titulo I requieren que cada escuela atendida bajo el Titulo I desarrolle y distribuya conjuntamente con los padres de los nifios participantes, una politica de participacion de los padres por escrito acordada por los padres que describa los requisitos descritos en la ley del Titulo I.

A. PARTICIPACION EN LAS POLITICAS

1. Convocar una reunion anual, en un momento conveniente, a la que se invitara y alentara a todos los padres de los nifios participantes a asistir, para informar a los padres de la participacion de su escuela en esta parte y explicar los requisitos de esta parte, y el derecho de que los padres se involucren;

Nuestra escuela tiene un discurso oficial sobre el estado de la escuela a fines de septiembre de cada afio escolar para revisar con los padres los requisitos de la escuela del Titulo I y la politica de participacion de los padres de la escuela. Ademas, el director les da a los padres una actualizacion sobre los datos de las pruebas, el estado de progreso anual adecuado y tambien facilita una revision del plan de mejora de la escuela.

2. Ofrecer un numero flexible de reuniones, como reuniones por la mañana o por la noche, y puede proporcionar, con los fondos proporcionados bajo esta parte, transporte, cuidado de nifios o visitas domiciliarias, segun se relacionen dichos servicios con la participacion de los padres.

Se invita a los padres a participar en una variedad de reuniones y actividades durante el transcurso del afio escolar. En septiembre se lleva a cabo una jornada de puertas abiertas para brindar a los padres la oportunidad de visitar formalmente el salon de clases de sus hijos para estar mejor informados sobre las expectativas de nivel de grado y el progreso academico de sus hijos. El contenido del centro de recursos para padres de nuestras escuelas se anuncia con frecuencia durante el afio escolar para resaltar los diversos libros y folletos, para uso domestico o como recurso en el campus.

Debido a los horarios agitados y variados de nuestra familia escolar, se hara un esfuerzo para brindar oportunidades de capacitacion a los padres a traves de enlaces en el sitio web de nuestra escuela, haciendo que la informacion este accesible las veinticuatro horas del dia.

Se invitara a los padres a participar en una conferencia de padres y maestros al menos dos veces al afio para discutir el progreso de su hijo. Los maestros pueden recibir a los padres por la

mafiana, durante el dia escolar y / o despues de la escuela para acomodar a tantos padres reciprocos como sea posible.

3. Involucrar a los padres, de manera organizada, continua y oportuna, en la planificacion, revision y mejora de los programas bajo esta parte, incluida la planificacion, revision y mejora de la politica de participacion de los padres de la escuela;

Nuestra escuela invita anualmente a los padres a participar en reuniones de revision y revision para examinar y discutir nuestro Plan de Mejoramiento Escolar y la Politica de Participacion de los Padres. Usamos una variedad de tecnicas comunicativas como nuestro manual escolar, boletines escolares, sitio web de la escuela, sitios web de aula, mensajero escolar (sistema de llamadas telefonicas), conferencias de padres/ maestros, reuniones de SST, reuniones de IEP, reuniones de PTA, reuniones del consejo escolar, notas individuales / llamadas a casa, noches de diversion familiar, encuestas (en papel y por telefono), sala de recursos para padres, talleres para padres, casa abierta, noche de regreso a clases, informes de progreso de mitad de periodo, boletas de calificaciones, resultados de referencia, puntajes de fluidez, etc. para solicitar la paiiicipacion de los padres y entregar informacion importante con la esperanza de crear un dialogo productivo entre el hogar y la escuela sobre la mejora del rendimiento estudiantil.
