- Your school has been assigned the IB information system (IBIS) school code, noted in the heading of the authorization letter (049388), and an online curriculum centre (OCC) code (70347). Please include your IBIS school code in all future correspondence with any IB office.
- As an IB World school, you will have access to IBIS, the IB school information system. We ask that you update school-specific information regularly on IBIS in order to maintain accurate records.
- 3. According to our records, you have appointed **Mrs. Melody Vizi** as the Primary Years Programme coordinator, through whom all queries and requests for information should be channelled. In addition to carrying responsibilities within the pedagogical leadership of the programme, your coordinator will serve as the intermediary between the IB Organization and your school community. It is the coordinator's responsibility to ensure that messages, correspondence and documents from the IB are passed on in a timely manner to the appropriate persons in the school community, including yourself. Programme-related information is accessed on the OCC via your coordinator and teachers, while school administration-related information will be sent directly to the head of school.
- 4. Your school's first evaluation will take place four years from now. Please consult the *Programme evaluation guide and self-study questionnaire: Primary Years Programme* for information on the evaluation process. This guide will also inform you of expectations from the IB concerning the development of the programme and requirements with regard to professional development in the period until the first evaluation. - 5. The coordinator should contact OCC support at <u>occ@ibo.org</u> to request that the OCC accounts for your candidate school code are transferred to your new OCC code. Once this has been done, your coordinator will be able to manage your school's OCC accounts on IBIS. The OCC is a password-protected site that provides essential support for coordinators and teachers delivering any of the IB programmes.
