School and Parent/Family Engagement Policy

C. JOINTLY DEVELOPED

<u>Attucks Middle School</u> will take the following actions to involve parents in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.
