## Student Parking Lot Expectations (2024-2025)

1. The 2024-2025 parking tag must be displayed (hanging on the rearview mirror) at all times and you must park in your assigned parking spot in the student parking lot. You are not allowed to park in any other parking lot on campus.
2. Obey all state traffic laws and school policies.
3. If your parking tag is lost or stolen, please report that to the main office immediately. You will be charged \$5 for a replacement tag.
4. Out of respect for our neighbors please do not play loud music from your car while on campus.
5. You are not allowed to go to your car or the student parking lot during the school day.
6. You are not allowed to leave campus during school hours. If you have a note from a parent to leave early, you must check out at the attendance office and exit through the front door.
7. You are not allowed to drive other students off campus or let other students drive your car on campus.
8. You must review the traffic plan and understand where appropriate entrance and exit points are for the student parking lot.
9. The speed limit in all parking lots is **10 MPH**.
10. Energy Institute High School is not liable for items that are lost, stolen or damaged while parked on campus. Lock your car, take your keys and hide your belongings.
11. If you get into an accident while on campus, it is your responsibility to follow up with the other driver, your insurance company and police if necessary.
12. If you park in an unauthorized spot, on campus, or do not have a parking tag, the student will be notified for the initial violation and a warning letter will be sent home. After 1 warning, the student driver will be fined \$10 per occurrence for parking without the proper documentation.
13. If you park in a fire lane, your car will be towed, on the first offense, at the owner's expense.
14. Any violation may/will result in forfeiture of your parking privilege on Energy Institute property. Parking fees will not be refunded.
15. If you have issues with habitual tardiness, you will first meet with your dean. If the tardiness continues after meeting with your dean, you will lose your parking privileges for the remainder of the semester and will need to find alternative transportation to school. Parking fees will not be refunded.

**By submitting this complete application, the student acknowledges and agrees to follow all parking lot rules and that any car parked in an unauthorized spot may/will be towed at the owner's expense.
