Engagement Policy

Parents are invited to attend various meetings during and after school, as well as evenings. We encourage parents to attend at least two of the eight meeting throughout the academic year. The school will host two major Title I meetings, one in the Fall and one in the Spring with alternate dates and times for your convenience. At these meetings, we discussed Title I mandates, requirements, rights and benefits. We will invite HISD personal, SSO and community leaders to help with presentations. Our presentations will be help in both languages English and Spanish. The Title I Coordinator will inform parents during Title I meetings about current educational programs and services under Title I. Agenda and Minutes of the Meetings will be uploaded on school webpage under Title I section. Parents will be informed of these meeting via school calendar, school webpage, and call outs as well as Crespo's ClassDojo and Facebook pages.

Program Engagement

During Parent and Family Engagement Meetings, the Title I coordinator will go over the school curriculum, assessments, expectations for our students, promotion standards, Texas Essential Knowledge and Skills (TEKS), State of Texas Assessment of Academic Readiness (STAAR), as well as an explanation on how the District and the school measures students' academic achievement and how the state measures our school accountability. Title I coordinator will also explain how our faculty and staff collaborate and

Parent & Family Training and Involvement

Crespo ES will hold four Parent and Family Engagement Meetings as well as Hands-on Mathematics and Reading Family Literacy nights to give parents the opportunity to be involved and informed in their child's education. During Parent and Family Engagement Meeting, parents and family members will have the opportunity to make suggestions, share experiences, and participate in the decision-making process. During Crespo ES literacy and math nights, parents will have the opportunity to learn alongside their children to better support them at home. Teacher will reach out to you during their conference time to discuss student progress. Teachers will send home materials to help parents work with their children at home such as math facts, HFW, leveled books, etc. You can also request a conference with your child's teacher at any time during their conference time. Volunteer and Visit

We love having volunteers in our school! All volunteers must register online and pass a criminal background check before they can participate as a volunteer. As per HISD GKG1 Policy, all HISD schools are required to use the VIPS/RAPTOR Volunteer Management system to track volunteers who are regularly providing services for, or on behalf of, HISD. Being a volunteer may require you to volunteer for a single trip or event, on the premises of District property or at a school-sponsored or school-related activity on or off school property. You will be required to register online each school year in VIPS/RAPTOR online application and agree to the annual background check. All volunteers must pass an annual criminal background check before volunteering at any HISD school. HISD reserves the right, in its sole discretion, to refuse and/or restrict an individual's access as an HISD volunteer based on an individual's criminal history, in accordance with applicable law and HISD policy, including HISD Policy GKG. Crespo ES will provide open communication with parents by phone, note, social media, or parent-teacher conferences to keep them informed of student academic progress. Parents are encouraged to schedule conferences visit the school website or call to inquired about teachers conference time. Please remember that Wednesdays of each week have been designated for Professional Learning Communities and teacher will not be available during their conference time. Crespo ES will provide highly qualified teachers that develop the academic, emotional, and physical well-being of the child as well as provide timely interventions for students in danger of not meeting state and district standards.

Parents will support the school and student academic success by bringing the student to school every day unless the student is very ill. Ensuring the students arrive to school by 7:30 am. Parents will communicate with teachers and principals by providing any information important to their child's performance. Parents will read notices sent home from school, including our school calendar and communication platforms via ClassDojo.
