- Child is a Resident of Houston ISD
- Child meets immunization requirements
- Parent must be-able to provide verification of Income for all income qualifying students

Meet at least one of the following conditions:

- Child is Limited English Proficient
- Child is homeless, as defined by [42 USC 11434a]
- Child is considered Economically Disadvantaged
- Child of an active duty member of armed forces
- Foster Care
- NSLP to include all children who meet any eligibility criteria for Head Start
- Child of a Star of Texas Award recipient
