TVFC Eligibility

ANY CHILD WHO IS 18 YEARS OF AGE OR YOUNGER AND MEETS AT LEAST ONE(1) OF

THE ELIGIBILITY CRITERIA LISTED BELOW IS ELIGIBLE TO RECEIVE THE TVFC VACCINE:

- ENROLLED IN MEDICAID OR IS MEDICAID-ELIGIBLE.
- IS UNINSURED.
- IS AN AMERICAN INDIAN OR ALASKAN NATIVE (BY 25 USC 1603);
- IS UNDERINSURED:
 - A CHILD WHO HAS COMMERCIAL (PRIVATE)

HEALTH INSURANCE, BUT COVERAGE DOES NOT INCLUDE VACCINES: OR

 A CHILD WHOSE INSURANCE COVERS ONLY SELECTED

VACCINES (TVFC-ELIGIBLE FOR NON-COVERED VACCINES ONLY): OR

- ENROLLED IN THE CHILDREN'S HEALTH INSURANCE PROGRAM (CHIP).
- A CHILD WHO HAS HEALTH INSURANCE COVERING ALL VACCINES, BUT THE PLAN HAS A FIXED DOLLAR LIMIT OR CAP ON THE AMOUNT THAT IT WILL COVER FOR VACCINES
- INSURED CHILDREN THAT HAVE MEDICAID AS THEIR SECONDARY INSURANCE (MEDICAID-

ELIGIBLE) ARE ELIGIBLE FOR THE TVFC VACCINE AND MUST NOT BE REFUSED VACCINE ADMINISTRATION

DUE TO THEIR INSURANCE STATUS.


