PURPOSE: The purpose of this meeting was to introduce the architects (HarrisonKornberg and Corgan) and continue work

on the Capacity Model and Space Requirements for Young Men's College Preparatory Academy.

#### **Discussion**

- 1. HarrisonKornberg/Corgan introduction.
  - a. They are a local Houston company that performed work for the district in 2007.
  - b. The team presented previous work performed for other districts and schools.
  - c. Discussed how current designs differ from traditionally designed schools and what makes them "21st Century".
  - d. Provided a brief over of LEED. What it is, different levels of certification and what they mean.
- 2. YMCPA Capacity Model.
  - a. The question was raised if the Capacity we are planning for is correct based on an incoming 6<sup>th</sup> grade class of 150 students.
  - b. Grade levels: 6,7,8, 9, 10 & 11
  - c. Enrollment: 415 students (150 incoming 6th grade)
  - d. Principal Crook explained the enrollment process and stated the target remains 125 per grade (875 total by 2018) with some flexibility.
    - i. He stated the Superintendent has mandated that no classes will be greater than 25
  - e. The Design Team will plan for 900 950 students
  - f. The PAT allocated 3 of the 6 Teaching Stations Specific to Program:
    - i. Robotics will have 2 Teaching Stations
    - ii. Computer Programming will have 1 Teaching Stations
    - iii. 3 unallocated Specific to Program Teaching Stations remain
- 3. Lecture hall
  - The PAT discussed the need for a lecture hall.
    - i. A benefit is simulating a college atmosphere
    - ii. Can be used for guest lectures; college professors, etc.
    - iii. Can be used for testing
    - iv. PAT discussed a lecture hall for 500 students
      - 1. Significant space required for a multi-tiered lecture space of that size
      - 2. PAT will continue this discussion and weigh benefits/need
      - 3. A lecture hall for 150 students was suggested as well

- 4. Another alternative was using the multi-purpose space in the cafeteria and designing a space that could be converted into a lecture style setting
- 4. PAT "Homework" to consider before next meeting.
  - a. Think about band/music/arts
    - a. How are we going to use?
    - b. How many students will use the space?
  - b. P/E Multipurpose
    - a. How will we use this space?
    - b. How many students will use this space and how often (how many periods of P/E a day)?
    - c. Will we need a weight room; cardio room?
  - c. How many staff members are anticipated once YMCPA reaches its enrollment target in 2018?
    - a. How many offices will be needed in the future?
    - b. How many work rooms will be needed in the future?

#### **Question and Answer**

- 1. Are we still discussing or have we determined if the new facility will be 2, 3 or 4 stories?
  - a. It remains unknown at this time. Once the Capacity Model is complete and the architects have completed a site review, we will see what works best for the YMCPA campus.
- 2. Which of the two buildings currently on the YMCPA campus will be incorporate into the new facility?
  - a. That is still to be determined. A very important piece in that decision making process will be an analysis by HarrisonKornberg of the suitability/viability of the two structures. After the data has been obtained, an informed decision can be made.

## What to Expect at the Next Meeting

- 1. Review updated Capacity Model.
- 2. Continue work on capacity model.
- 3. Begin reviewing Site Specific Educational Specifications.

#### **ACTION ITEMS:**

- 2-01 Update YMCPA Capacity Model (HISD Facilities Planning).
- 2-02 Gather facility data on buildings currently located on YMCPA campus (HarrisonKornberg/Corgan).
