PURPOSE

The purpose of this meeting was to review and discuss further components of Design Development.

NOTES:

Michael Scott with the HISD Bond Office introduced George Watanabe with cre8 architects who
presented and reviewed with the PAT, updated components of the current design which is currently in
Design Development stage of the overall project.



- Cre8 discussed the possible use of concrete tilt up walls in lieu of masonry as an exterior finish. The
 advantages were that they could be poured on site speeding up installation thus enhancing the overall
 project schedule. The disadvantage would be aesthetics.
- Cre8 presented and reviewed updated 1st and 2nd floor plans with the 2nd floor plan showing greater flexibility. The kitchen area was reviewed with kitchen equipment in place and confirmed to have back up power supportive to same.
- Cre8 also presented and reviewed with the pat 3 colorized sets of exterior elevations distinguished as follows:
 - Elevation Option 1 Medium tone in color
 - o Elevation Option 2 Primary Colors
 - o Elevation Option 3 Dark Colors
- Cre8 discussed and reviewed the current and proposed restroom fixture count with discussion offered to the following points:
 - The pat confirmed that there was a current issue with the restrooms throughout the existing school.
 - The SSO recommended a study of the Walnut Bend current restroom layout be used as referenced.
 - HISD Design advised that any restroom design could add costs to current budget.
 - The principal inquired about the possibility of adding a restroom adjacent to the proposed dining area.
 - The pat advised that the corridors in the existing school are used as holding areas for the use of all restrooms.
 - Cre8 agreed to revisit the overall design of all restrooms in the current design.
- The pat provided the following feedback regarding the exterior elevations presented as follows:
 - Option 2 not selected; Option 1 medium tone selected; Option 3 Dark tone selected
 - Cre8 agreed to further develop Options 1 and 3
- Mr. Scott provided the pat with an update on the status of the swing space. He also confirmed that HISD and cre8 would be meeting with both the principal and assistant principal regarding inclement weather and ADA access from proposed temporary parking lot to school during construction.
- The pat advised that perimeter fencing around the new school along with outdoor play space during construction would need to be addressed at some point in the very near future. They also requested HISD to confirm the outdoor play requirements for a temporary duration.
