  - City of Bellaire issued the Building permit for Condit Elementary school on March 6, 2015. The permit authorized Division One to start construction of the building itself.
  - Mr. Gee informed the PAT that Division One has started construction and will be roughing out the building pad and installing site utilities over the next few weeks.
