Discussion:

- 1. VLK Architects presented the final site plan that meets City of Bellaire requirements.
- 2. VLK Architects reviewed the floor plans. It was noted that the floor plans have not changed since the last PAT meeting.
- 3. VLK Architects presented finish Option 1a:
 - a. The PAT voiced some concern about the amount of green included and noted that even the use of "Condit Green" seemed overbearing.
 - b. The PAT requested an additional field color be incorporated in this scheme to reduce the amount of green.
- 4. VLK Architects presented Option 3:
 - a. The PAT voiced concern that the color palette was too cool and institutional.
- 5. VLK Architects presented Option 4:
 - a. Some of the PAT liked the brown/neutrals; others did not like the palette for use in an elementary school.
- 6. Overall comments:
 - a. The PAT requested that the floor pattern be revised. It was suggested that pattern be more directional to assist the students in moving through the building in lines.
 - b. The PAT wants to proceed with the carpet from the previous option 2 presented at the July 31, 2014 PAT meeting.
