PURPOSE: Discussions focused on updating the PAT on the status of Construction.

DISCUSSION:

- 1. Tellepsen, the Construction Manager at Risk gave the following construction progress report:
 - Final pricing has been received and the current market pricing is higher than anticipated; we are working with the sub-contractors to develop alternates.
 - We are removing the remainder of the Shamrock Hotel basement. Backfill will start this week and last 10 weeks and we will start drilling test piles in late April 2015.
 - Displayed jobsite photos to PAT meeting attendees.
- 2. Mary Hayes asked if the walking trail was included in the budget and what material is being used to construct it. Steven Gee, the Project Manager confirmed the jogging trail is in the design. The running trail will be a designated area circling the parking lot.



3. Mrs. Hayes asked if the school would have control of the gates at the school to restrict access. *Mr. Gee noted the school will have complete control over the entrance and exit gates to the campus.*

ACTION ITEMS:

- 27.01 Raj Vadlamudi requested floor plans, electrical and grading drawings for the review of the PAT members. *The drawings will be presented at the next PAT meeting. (Project Manager)*
- 27.02 Mr. Vadlamudi presented a request for additional electrical outlets in the classrooms. *The Architects have designed the school to HISD's specifications and has met the needed requirement. (Project Manager)*
- 27.03 Mr. Vadlamudi presented a request for a copy of the Traffic Study Report. A summary of the report will be presented at the PAT meeting once the plan has been approved. (Project Manager)
- 27.04 Mr. Vadlamudi requested access gate to parking lot separate from gate to premises. WHR Architects will investigate a system that can be installed to restrict access to the parking lot.
- 27.05 Mr. Vadlamudi asked when the furniture catalog will be available. The FFE Department will contact the Principal eight to ten months prior to the school opening to start discussions on furniture selection. (Project Manager)
