- 1. The PAT reviewed the school mission statement and determined that this would be the basis for their Guiding Principles. PAT members will compile their ideas and meet to finalize the Principles.
- 2. The Capacity Model process was presented. The target for the school is 800-1000 students. The group began to identify spaces that would be required for grades 9-12. (Presently the school has only 9th grade students.) The outcome of the discussion for the capacity of the school is shown below. However, the PAT expressed a desire to look at this more in depth with additional teachers. Therefore, Principal Lambropoulos and her staff will review their program needs for a school with 9th through 12th grade and propose revisions prior to the next PAT meeting.
