PURPOSE: The purpose of this meeting was to provide an update of the overall project status and construction status report.

DISCUSSION:

- 1. Michael Scott, Program Manager opened the meeting with introductions of Dustin Fredrickson, Assistant Project Manager, KBR Building Group, and ERO Architects.
- 2. Ms. Bertie Simmons advised the PAT of a potential Ground Breaking date of 4/18/15; Ms. Simmons also stated that the date could potentially be moved to a weekday in an effort to generate interest from the enrollment.
- 3. ERO Architects provided a presentation outlining the location of the detention ponds on the existing Site Plan.
- 4. KBR Building Group presented slides outlining the construction phasing of the project.
- 5. Mr. Scott provided an update on the status of the building permit per information provided by the City of Houston Department of Buildings.
- 6. The PAT members expressed concerns relative to the 2017 project completion date. Michael Scott advised that the program manager would be the responsible party tracking any substantial delays encountered throughout the project and report back to the PAT at upcoming meetings
- 7. Eli Ochoa (ERO Architects) advised that ERO has hired a permit expeditor to assist with the City of Houston permitting process. Mr. Ochoa also explained that the phasing of the project is critical to not increasing rain water runoff onto Mercury Drive.

QUESTIONS/ANSWERS:

- 1. What are the depths of the proposed detention ponds?
 - a. Mr. Cantu confirmed the depths of the ponds to be approximately six feet.
- 2. Will the detention ponds address the flooding on Mercury Drive?
 - a. The construction team advised that although the detention ponds would not increase any flooding, and were not specifically designed to solve a flood problem on Mercury, they would mitigate some flooding in this area.
