PURPOSE: The purpose of this PAT meeting was for the PM to provide an update on priorities/budget reconciliation and design progress update.

AGENDA:

DISCUSSION:

- 1. Spencer Wingate, Senior Project Manager with Rice & Gardner Consultants kicked off the PAT meeting and explained that this meetings purpose was to serve as a design update for project.
- Before Mr. Wingate introduced the design team, he provided an update of the scope of work. The update of the scope of work was stated to include the full renovation of the main building or Building "A".



- 3. Mr. Wingate explained that the decision to include that scope of work was recently confirmed and the subsequent design has not yet been included in the Design Development set of documents.
- 4. PAT members asked questions regarding this new scope change and the following clarifications were provided:
 - a. Building A renovation will include the reconfiguration of classroom sizes and their walls.
 - b. Inclusion of Building A renovation does not delete the science building renovations or the Gymnasium addition.
 - c. The project schedule may be adjusted but the temporary buildings will be installed prior to the start of the main project construction.
 - d. The PAT requested a set of DD drawings which will be delivered to Dr. Pollock.
 - e. The PAT requested a copy of the draft Education Specifications. Dr. Pollock stated that this is available in the office for the PAT to reference.
 - f. Mr. Wingate provided an outline of the design process and the specific milestone phases: Schematic Design (SD), Design Development (DD), 60% Construction Documents (60% CD) and 100% Construction Documents (100% CD).
- 5. Mr. Sam Swart, of Hill, Swart and Chu, presented the design progress in the form of the Community meeting presentation.
- 6. PAT members pointed out issues that the community will be interested in hearing addressed:
 - a. Status of the Sue Barnett Road improvements from the CoH and the impact on traffic including possible changes to the circle drive
 - b. Efforts to save trees
 - c. Construction staging located in the Spark Park and to what extent
