NOTES:

- 1. David Funk HISD Facility Planning reviewed revisions to the space requirements discussed in the previous session. Comments included:
 - a. The guidance officer can serve in tandem with the magnet office and neither have to be contiguous to the administrative office.
 - b. A school store was added. In exchange the athletics lobby was reduced a corresponding 200 SF.
 - c. The nature of the drama lab as a black box versus teaching space was discussed.
 - d. The JROTC program is atypical of other schools because a separate firing range is provided.
 - e. The firing range will be discussed further particularly if space is collocated with police. The requirements for the police shooting range will likely be somewhat different from those required by HSLECJ.
 - f. Arms storage is currently located with the learning space but can be located with the firing range if possible.
 - g. "Hogan's Alley" requested by HISD police.
