  - c. During the afternoon Page will develop the ideas shared in the morning session and prepare documentation for the second day's session.
  - d. The charette will reconvene for the second day to review the work from the previous day and further develop those concepts. The PAT will interactively participate with Page to create a conceptual design for HSLECJ.
- 4. Ken Black of Page reviewed the subsequent design process including the participation of the Construction Manager at Risk (CMAR).
