Mr. Spencer Wingate, Sr. Project Manager with Rice & Gardner Consultants, welcomed the participants to the PAT meeting.

- 1. Mr. Wingate, provided a project status update to the group. The following information was provided:
 - a. GMP Schedule
 - 1) Phase 3 GMP bid submission will be provided by Cadence McShane Construction on February 10, 2015.
 - 2) Once bids are received, a period of verification, qualification and refinement will occur to provide the best possible pricing. Ideally, this process will be complete before the next PAT meeting in March.
 - b. Budget Update
 - 1) The original budget of \$48,397,050 was increased to \$57,773,121 to adjust for the current price escalation in the construction market.
