## **DISCUSSION:**

R. Scott Allen, Ed.D, Principal, welcomed the participants to the PAT meeting.

- 1. Mr. Spencer Wingate, Sr. Project Manager with Rice & Gardner Consultants introduced Mr. Bill Stewart, Sr. Project Manager with Cadence McShane Construction, to provide a project status update to the group. The following information was provided:
  - a. GMP Schedule
    - 1) Phase 1 GMP The completed, soil retention design work is nearing completion.
    - 2) Phase 2 GMP Earthwork bids are due on 12/11/14.
    - 3) Phase 3 Final GMP will bid in late January 2015.
  - b. Milestone Schedule
    - 1) The removal of the existing foundations will begin on 12/16/14.
    - 2) The Retention System installation will begin in the first half of January, 2015.
- 2. Mr. Stewart provided an update on the large live oak tree in the easement of Rusk Street. The city will be requiring the project to adhere to a preservation plan designed to help save the tree from being destroyed during construction
