- John Haugen, Project Architect for NATEX Corporation, presented and reviewed the schematic design concept that was finalized during the Design Charrette. There were several members of the PAT that were not able to attend the Design Charrette, therefore, changes within the concept developed further within the Charrette process were discussed.
- 2. The Program Manager (Douglas Lacy) and the Project Architect (John Haugen) outlined the Schematic Design Approval process and the deliverables required to HISD Facilities Planning and Design. John Haugen presented the Schematic Design package for the PAT's review.
- 3. During the presentation of the floor plan of the new entrance addition, Princess Jenkins, HISD Facilities Planner, recommended switching the location of the Attendance Office and the Receptionist Office.



- 4. There was one change addressed by the PAT for the existing building renovation plan review. The Architect was directed to relocate the Life Skills Lab to the East side of the Corridor of Building "A" so that the classroom would receive natural light into the space.
- 5. The Architect shall review the Science Labs to determine the square footage of the existing rooms whether or not they meet the square area of the labs outlined in the Education Specifications.
