B3Ci the current progress of the job. B3Ci went through the items that are being done currently on the project which included erection of structural steel, slab on grade pours, paving and storm installation.

Dr. Fernandez asked what would get moved from the old building to the new building. Kwame said that he will get HISD to contact him on that.

Dr. Fernandez asked if any of the existing North Forest HS structures would remain. Kwame said there are no plans at the moment to keep anything. Dr. Fernandez mentioned that the existing gymnasium is reusable.

Dr. Fernandez said that construction work will need to be carefully coordinated in December so as not to conflict with testing. B3Ci agreed.

B3Ci is assembling GMP #3. This will be the last GMP until demolition of the old high school.

LEED Credit – School as a Teaching Tool

KWAME is getting the syllabus from the environmental class at Worthing.

Permit and Revisions:

Page is making revisions to the drawings for the area concerns in the class rooms. The permit for GMP #3 is currently being processed by the city. Currently Page has seen very few concerns. Mostly they need information from the first two permits.
