PURPOSE: The purpose of this meeting was to review and select a conceptual floor plan for schematic

development.

What to expect at the next PAT Meeting

Discussion:

- 1. H. Sonny Fletcher opened the meeting and introduced Daniel Kornberg, architect with Harrison Kornberg who will be reviewing the floor plan.
- 2. Daniel Kornberg, of Harrison Kornberg, presented the floor plan.
 - a. Lecture hall was moved to be adjacent to the High School courtyard; this allows the three robotics spaces to be grouped together.
 - b. The PAT noted that flipping the Art room storage to the other side of the room will allow the space to be more open to the corridor.
 - c. The PAT asked how the multi-purpose room moved from being across from Robotics to the new location adjacent to the High School Commons. Per the Educational Specifications for YMCPA the multi-purpose room should be adjacent to the serving area and close to the High School side.
 - d. The PAT noted potential uses for the exterior play court to be box soccer, and outdoor floor hockey.
 - e. At the High School Special Education classroom add a door from the teacher workroom to the kitchen and restroom. It was noted that the Educational specifications require the restroom to have a shower.
 - f. The PAT recommended moving the Small Group Instruction space to be adjacent to the teacher workroom, this will allow better supervision.
 - g. The PAT asked what the ceiling height will be in the lecture hall, response 14'-6".
 - h. The lecture hall seating was discussed and it was agreed to have built-up risers, which are easy to demolish if the use of the space should change, and have fixed desk with chairs.
 - i. The PAT requested that the shelving in robotics be open to the corridor, to allow showcasing of student work.
 - j. The PAT asked if the High School Science learning centers have garage doors to the exterior. Response: We are working on the science room layouts; the requirement to have perimeter sinks is limiting the location of a garage door to the courtyard.
 - k. The PAT asked what material will be on the walls adjacent to the courtyards. Response is as much glass as the project budget allows.
 - I. The PAT requested in the middle school courtyard adding a covered area.
