DISCUSSION:

1. Michael Scott, HISD Program Manager opened the meeting introducing Harrison and Kornberg Architects as additional presenters.
2. Michael Scott provided an update regarding the status of the CSP delivery method.
3. Harrison & Kornberg provided a presentation reflective of the revised Exterior Façades proposed for the Gregg and Lyons Street Elevations. HKA also presented a review of the current Site and Floor plans.
4. Mr. Crook advised that he did not remember the Art Courtyard space. HKA confirmed that the use of the space would not have to be used only as an art space; HISD advised that the space could be researched and possibly priced for classroom space as well.
5. Mr. Crook requested that a monumental/marquee type sign be used on Lyons Street as in was a major thoroughfare and means of access to the school.
6. One PATmember offered to provide a sample elevation at the next meeting which would be forwarded on to HISD via Mr. Crook.
7. Mr. Crook confirmed that the remaining summer PAT meeting scheduled for 7/22/2015 and 8/19/2015 would begin at 11:30am with lunch served in lieu of 9:30am.

QUESTIONS/ANSWERS:

1. One PAT member asked "Is that a carport ?" in referenced to the entrance canopy along the Gregg Street elevation. HKA reviewed and explained that it was not a carport but a canopy and provided an explanation/clarification of its use and purpose.
2. PATmembers were not in agreement with the letters noting the school name currently hanging from columns supporting the proposed canopy. HKA to research alternate method.
3. HISD advised that marquee letters function separately and that the school is slated to receive a marquee sign. The two items should not clash on the campus.
