## FACILITY SERVICES UPDATES (Exec. Officer Alishia Jolivette Webber)

Shared updates on facilities work orders and safety and security concerns. For the fiscal year of 2022-2023, the total open work order is 76,790 and closed 75,713. It projected the safety security work orders closed from January 1, 2023, through June 30, 2023, for the grand total of 4,599. As of June 30, 2023, the total of outstanding work orders to complete is 2,882. Shared exterior doors work requests, a total of open 69 and closed 45.

#### **Presentation of Current Projects:**

- Door numbering of all campuses, twenty (20) schools are completed and ongoing.
- Window film: The project installations begin mid-August 2023. Fourteen (14) schools have purchase orders assigned for work to begin. Phase 1 will be all elementary, phase 2 will be all middle schools, and Phase 3 will be high schools based on available funding.
- Fencing projects are ongoing and under review.

Upcoming Projects are water quality testing and air quality testing.

## HISD POLICE DEPARTMENT UPDATES (Manager Melissa Lopez)

Shared the contract with Raptor Technologies, and showed the list of modules that will be added to Raptor.

- ✓ Student Safe Behavior Threat Assessment tracking managed by the Counselling Department.
- ✓ Drill Manager Emergency Drill tracking is managed by the Safety and Emergency Management Department; access will be given to safety captains to ensure the required drills are conducted.
- √ Raptor Alert Quick reporting of emergencies on campus. This is a work in progress, it will roll out next semester.
- √ Raptor Accountability Accounts for students and staff during an emergency. Teachers and staff will quickly account for students via phone or desktop applications.
- √ Reunification Quickly facilitates the reunification of students and staff. It will be carried out the next school year.

### SAFETY AND EMERGENCY MANAGEMENT UPDATES (Manager Melissa Lopez)

Shared the 2020-2023 Safety and Security Audit that will further be discussed during a closed session. This audit is required every three (3) years by the Texas School Safety Center (TxSSC). The Safety and Emergency Management Department complies with the audit reporting information with assistance from various district departments to effectively respond. The responses will be provided to the District's Board Managers. This is due on September 15, 2023.

**Question:** The Raptor Technology, is that an app that can be downloaded to student's phones, teachers, and custodians? **Answer:** As of now, only for the school staff, and the students is a work in progress. **Question:** Is there an age limit with the students? **Answer:** Not that the Police Department is aware of.
