## COVID-19 Update (Jackie Birmingham)

- Vaccination Progress: 55.8% of Harris County residents have received at least one dose of vaccine; 46.2% of all Harris County residents are fully vaccinated, 67.6% of all Harris County residents ages 12+ have received at least one dose, and 56.1% of Harris County residents ages 12+ are fully vaccinated
- o COVID-19 positivity rate is 19.6% as of Friday, August 13, 2021
- New Case Trend for Harris County
  - increases by 51 cases per day
  - weekly total of new cases per 100,000 residents reported within 7 days of test date is 285 cases per 100,000 residents
  - HISD COVID Cases as of August 8, 12 employees confirmed as COVID positive
- Latest Update for Procedural Guidelines for HISD
  - New exception to procedure is if an employee is fully vaccinated and it has been 14 days after the final dose and has been exposed to someone with a positive or presumed positive, the employee does not have to quarantine if the employee is not exhibiting symptoms
  - All other guidelines for a confirmed positive case are in effect.

### **HISD Police Department Updates** (HISD PD Chief Lopez)

- Mandatory training required by the state occurs in July and August; HISD PD concludes annual firearms qualifications this week.
- o Anonymous Alerts System will be launched for the upcoming school year.

- ICS/NIMS Safety training begins in the fall and will be completed by January 2022.
- Situational Awareness needed: two dozen catalytic converter thefts have been reported around the district

# Anonymous Tip App Update (Roberta Scott)

- App will launch in October/November, will conduct anonymous 2-way dialogue/communications with a student or parent
- o District will receive incident reports in real time from students or parents
- App can provide full notetaking and tracking of each anonymous incident report
- App is a result of three-year grant from collaboration between Social-Emotional Learning department and HISD PD

# Risk Management Updates (Melissa Lopez)

- General Safety Training available as compliance course and is assigned to all employees
- National Incident Management System (NIMS) training for selected employee groups assigned based on guidance from Senate Bill 11 and the Texas School Safety Center
- Risk Management Kickoff Meeting with campus principals was held August 10, 2021
