Health/Medical Services Update (Candice Castillo)

An update was provided information of community low spread of COVID-19 cases, comparison from year 2021 to 2022. To continue to be proactive in ensuring in keeping school campuses to follow the guidelines, reminding protocols that have in place and addressing potential spikes and cases. Presented COVID-19 Dashboard updates, wastewater results, 2022-23 Testing Program and Monkeypox Data.

Social Emotional Learning Update (Roberta Scott)

The School Based Healthcare Solutions Network Grant Program is under with Mental Health Service. TCHATT District Mental Health Services are in twenty-six (26) HISD schools, partnering with Baylor College of Medicine and University of Texas. The SEL Department has provided hours of support to the following, Behavior Support, SEL Campus needs assessments, Trainings, Classroom Observations, and one on one student support. Presented 2022-2023 HISD Crisis Calls, Sandy Hook Promise (SSARS). The Hero's Program has been approved; this is a partnership with HISD Police Department. There will be two (2) officers reporting to SEL, tag teaming with Crisis Calls.

HISD Police Department Update (Assistant Chief Lucretia Rogers)

Six Radar trailers and Six Handheld Radar Units have been deployed to high traffic school areas and are moved around depending on traffic concerns since the beginning of school. One radar trailer has been permanently assigned to the area of North Forest High School due to increased traffic safety concerns. Police vehicles have strategically been positioned at our larger high schools in an effort assist with safety coverage at our elementary schools as needed. Narcan has been distributed to all sworn personnel and training for its used has been completed by all police officers. Ballistic Shield Training has started, as of now 59 officers had been trained, and training is given twice a week. Intruder Drills, the HISD PD civilian staff are completing unannounced visits to schools with an approximately 15 to 18 drills being completed per week. The HISD PD and Social and Emotional Learning Department continue to work closely to better assist our students with crisis intervention needs within the district.

Risk Management Update (Alexis Licata)

Presented information regarding the upcoming 2020-2023 District Audit Report – Texas School Safety Center. Per the Texas Education Code 37.108, section 37.108(b) at least once and every three years, each school district or public junior college district shall conduct a safety and security audit of the district's facilities. The Audit Cycle is from November 1, 2020, to August 31, 2023. The DARtool consists of questions pertaining to district's safety and security audit results. The audit results must be submitted to TxSSC using the online District Audit Reporting Tool due by September 15, 2023.

An academic service memo was sent out on September 9, 2022, regarding weekly door sweeps, specifically requesting that school principals identify a primary and alternate contact responsible for conducting and entering the information into iDelegate. A door sweep template was provided for employees to track and document their weekly door sweeps. Risk Management is working with IT to implement a Power App to allow campuses to electronically enter their weekly door sweep information in real time. This will allow immediate access to show who is in compliant and any deficiencies they may have with exterior doors on their campus.
