### **School Responsibilities**

Sinclair Elementary School believes in success for 100% of our students. Therefore, as a school we will:

- 1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards.
  - a. Teachers will have access to the HISD curriculum and campus purchased instructional resources.
  - b. Administrators will work closely with teachers to improve the quality of instruction by providing timely feedback, support, and coaching.
  - c. Professional Development opportunities will be made available to all staff members.
- Hold parent-teacher conferences during which this compact will be discussed as it relates to the individual child's achievement. The conferences will take place as requested by parent/guardian or teacher.

- 3. Provide parents with frequent reports on their children's progress. Progress reports will be sent home by the end of the 3<sup>rd</sup> week of a grade reporting period. Additionally, parents can access Parent Connect Portal in PowerSchool to monitor their child's academic progress at any point during the year.
- 4. Provide parents reasonable access to staff. Staff will be available for parents by appointment during their planning period. Additionally, parents can contact teachers by phone or via email to check on student progress. Staff will respond to parent contact within 24-48 school business hours.
- 5. Provide parents opportunities to volunteer and participate in their child's education. Parents can volunteer in classrooms as room parents or on campus, chaperone field trips, and observe in classrooms as per our observation policy found in the family handbook.

#### Parent/Guardian Responsibilities

As a parent at Sinclair, I believe that my child will succeed. Therefore, I will support and encourage him/her by doing the following:

- 1. Ensure that my child is punctual and attends school regularly with materials needed to learn.
- 2. Support the school in its efforts to maintain proper discipline and dress code requirements.
- 3. Establish a time for homework and review it regularly.
- 4. Provide a quiet well-lighted place for study.
- 5. Encourage my child's efforts and be available for questions.
- 6. Monitor my child's progress using the Parent Connect Portal.
- 7. Keep the school informed of any major life changes that can impact my child's ability to learn.
- 8. Read with my child at least 20-30 minutes per day and let my child see me read.
- 9. Participate, as appropriate, in decisions relating to my child's education.
- 10. Communicate with the school by promptly reading all notices from the school or school district.
- 11. Attend parent conferences.
