  - c. Memorial also has a monthly newsletter that goes out to parents via Parent Square.

  - a. Teachers will post weekly updates on Parent Square, return Parent Square messages, emails and phone calls within 48 business hours.
5. Provide parents with opportunities to participate in school activities.
  - a. Volunteer as a parent.
  - b. School events such as the Annual Fall Festival, Field Day and VIPS approved volunteering.
  - c. Join the school PTO
