Attached is the Student Disciplinary Action Report for 2020–2021. The report is organized according to the coding categories used by the Texas Education Agency (TEA) and includes the number, rate, and type of violent or criminal disciplinary incidents that occurred on each campus.

Key findings include:

- In 2018–2019 and 2019–2020, the total number of in-school suspensions and out-of-school suspensions were each above 10,000, but in 2020–2021, there were only 408 in-school suspensions and 820 out-of-school suspensions. The drastic decrease can be attributed to the COVID-19 pandemic and the time that students spent in virtual learning environments.
- In 2020–2021, there were 64 referrals to disciplinary alternative education programs (DAEP) and three expulsions to juvenile justice alternative education programs (JJAEP).
- In 2020–2021, students who were male, Black, receive special education services, economically disadvantaged, or considered at risk received disciplinary actions at a disproportionately higher rate.
- In 2020–2021 for students in prekindergarten (PK) through 2nd grade, the number of total in-school suspensions decreased to seven and the number of total out-of-school suspensions decreased to two.
- In 2020–2021, 9th grade students had the largest proportion of in-school suspensions (24.8 percent), 8th grade students had the largest proportion of out-of-school suspensions (19.0 percent), and 9th grade students had the largest proportion of referrals to DAEP (18.8 percent).

Administrative Response

The Social & Emotional Learning and Student Discipline Department impacts student performance through building effective supports on campuses and assists them in expanding their capacity to create systems to ensure the safety of all students and staff. Implementing SEL strategies can lead to a reduction in misbehavior and emotional dysregulation which allows for more effective instructional time, reduces the need to constantly correct misbehavior, and decreases the use of exclusionary consequences (e.g., out of school suspension). SEL skills can significantly improve scholars' emotional growth, character development, mental health, and academic performance.

The Social and Emotional Learning and Student Discipline Department is committed to reducing the impact of exclusionary disciplinary practices on our students. The SEL Department offers resources and services to help students develop skills to manage their emotions, form positive

relationships, feel empathy for others, and make responsible decisions. Social/Emotional Learning and Student Discipline programming is based on evidence and research-based understanding that the best learning emerges in the context of supportive relationships that make learning challenging, engaging, and meaningful.

The SEL Department focused on increasing the capacity of administrators and teachers to shape and sustain campus-wide Positive Behavioral Interventions and Supports (PBIS), Culturally Responsive Teaching, Restorative Discipline Practices, and SEL curriculum to increase equity in the district, decrease exclusionary discipline-related practices, and offer alternatives to suspension.

In 2020–2021, the following was accomplished:

- Heightened campus awareness of the Education First Substance Abuse model, which in lieu of DAEP placement provides an educational and therapeutic opportunity for students who have had a first-time drug-related offense on the campus by including substance abuse clinicians, who work directly with students at their campus of enrollment.
- Reintegrated access to the SEL online curriculum platform which provides a framework for mental health, wellness instruction and knowledge, and includes K-12 teacher component.
- Maximized the "Let's Stay Connected" Houston ISD Mental Health Hotline that addressed all levels of Mental/Behavioral Health for our students, teachers, and parents.
- Reinforced and promoted The Sandy Hook Promise initiative, which equips students with an anonymous reporting tool to prevent self-harm, harm to others, and bullying.
- Increased the number of Intensive Mental Health Specialist positions to provide support for students through an increase in intervention and response tools and resources.
- Accelerated our partnership with the HISD Police Department to provide ongoing training on Nonviolence Crisis Response Intervention and Mental Health.
- Launched the extended topics of the SEL Mental Health curriculum, which incorporates suicide prevention and trauma-informed practices into academic lessons.
- Boosted our Mental Health and Wellness Initiative for HISD students, teachers, and families. It addresses the specific needs of identified targeted campuses by building their capacity to implement a plan that increases student academic and social/emotional outcomes through the connection of SEL and academics.
- Emphasized our support for Alternatives to Suspension initiatives that focus on supporting students with social-emotional learning skills, restorative practices, mentoring, and other alternatives to suspension while ensuring that each student remains on track to graduate.

SEL continues to work on decreasing Student Code of Conduct violations, exclusionary disciplinary practices, and racial disproportionality in disciplinary actions by providing districtwide professional development and support that primarily focuses on proactive and preventative whole-student social and emotional strategies and development.

In addition, the SEL Department hosts student discipline management professional development opportunities for all Tier II Leaders, Campus Discipline Coordinators, and other administrators involved with student discipline management. The training includes the following topics: understanding school systems that encourage the development of positive staff/student relationships; positive behavioral techniques; an understanding of the HISD Code of Student Conduct; and the referral process and procedures for placement in the Discipline Alternative Education Program (DAEP) and the Juvenile Justice Alternative Education Program (JJAEP). Participants also gain knowledge of revisions to the Texas Education Code Chapter 37 and HISD Board Policy.

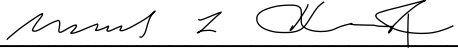
All referrals to the Discipline Education Programs are centrally reviewed and processed to ensure that students' rights to due process are safeguarded, alternatives to removal have been considered by campus administrators, and that campus disciplinary practices are aligned with the HISD Student Code of Conduct.

The HISD Code of Conduct is reviewed by the Board annually. The Code has evolved over the years to include language that addresses the following: minimizing exclusionary consequences; emphasizing the importance of instructional time; focusing on social and emotional interventions and supports; the need for on-going parent/guardian communication; protecting the student's right to due process procedures; and safeguarding the right to a safe and respectful learning environment.

For the 2021–2022 school year, Social/Emotional Learning, Student Discipline, along with the HISD Police Department, will continue to embrace and prioritize the different needs of students and staff as HISD adjusts to learning in the current environment. Through the STOP the Violence Grant, services will continue to be provided virtually and face to face as outlined by the TEA protocols and CDC standards. Mental Health & Trauma Informed Training will include additional staff-training on classroom interventions and protocols that effectively recognize signs and symptoms of trauma and mental health in students. Trainings focus on student and staff mental health, trauma informed practices, crisis response intervention and protocols, and parent support. The goal is to increase the capacity of staff to recognize the signs of crisis and the impact of trauma in order to put in place preventative and supportive measures that may prevent more serious outcomes such as suicide and/or other forms of violence.

Lastly, our continued community partnerships enable their staff to support counseling services on our campuses for extended intensive direct and group services.

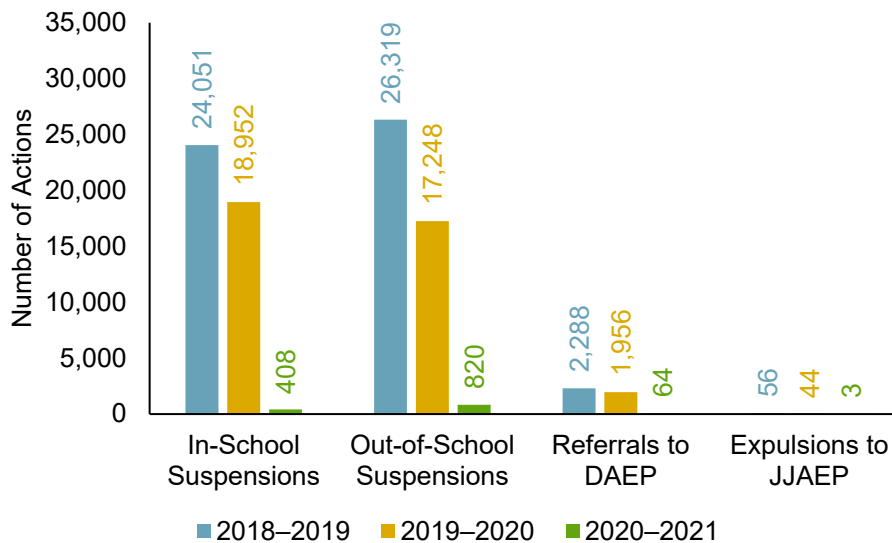
Methods

Discipline data were taken from the 2020–2021 PEIMS Summer Resubmission file, and enrollment and demographic data were taken from the 2020–2021 PEIMS Fall Snapshot file. In the report, duplicate counts of actions refer to the total number of incidents, not the total number of students. Unduplicated counts indicate the number of students that committed a particular offense.

Results

Figure 1 shows the duplicated number of disciplinary actions for the past three years. Due to the COVID-19 pandemic, caution should be taken when comparing 2020–2021 to previous years.

Tables 1–4 (pp. 3–6) show the enrollment, number and proportion of unduplicated disciplinary actions, and number and proportion of duplicated disciplinary actions by gender, race/ethnicity, and other demographic groups. Compared to enrollment proportions, students who are male, Black, receive special education services, economically disadvantaged, or considered at risk received disciplinary actions at a disproportionately higher rate.

- In 2020–2021, 50.4 percent of HISD's students were male, but out of the 347 students who received in-school suspensions, 59.4 percent were male.
- In 2020–2021, 22.4 percent of HISD's students were Black, but out of the 347 students who received in-school suspensions, 30.8 percent were Black.
- In 2020–2021, 8.2 percent of HISD's students received special education services, but out of the 347 students who received in-school suspensions, 13.5 percent were in special education.
- In 2020–2021, 78.5 percent of HISD's students were economically disadvantaged, but out of the 347 students who received in-school suspensions, 86.2 percent were economically disadvantaged.
- In 2020–2021, 52.7 percent of HISD's students were considered at risk, but out of the 347 students who received in-school suspensions, 65.7 percent were considered at risk.

- In 2020–2021, 50.4 percent of HISD's students were male, but out of the 672 students who received out-of-school suspensions, 59.2 percent were male.
- In 2020–2021, 22.4 percent of HISD's students were Black, but out of the 672 students who received out-of-school suspensions, 40.0 percent were Black.
- In 2020–2021, 8.2 percent of HISD's students received special education services, but out of the 672 students who received out-of-school suspensions, 16.1 percent were in special education.
- In 2020–2021, 78.5 percent of HISD's students were economically disadvantaged, but out of the 672 students who received out-of-school suspensions, 82.9 percent were economically disadvantaged.
- In 2020–2021, 52.7 percent of HISD's students were considered at risk, but out of the 672 students who received out-of-school suspensions, 60.9 percent were considered at risk.

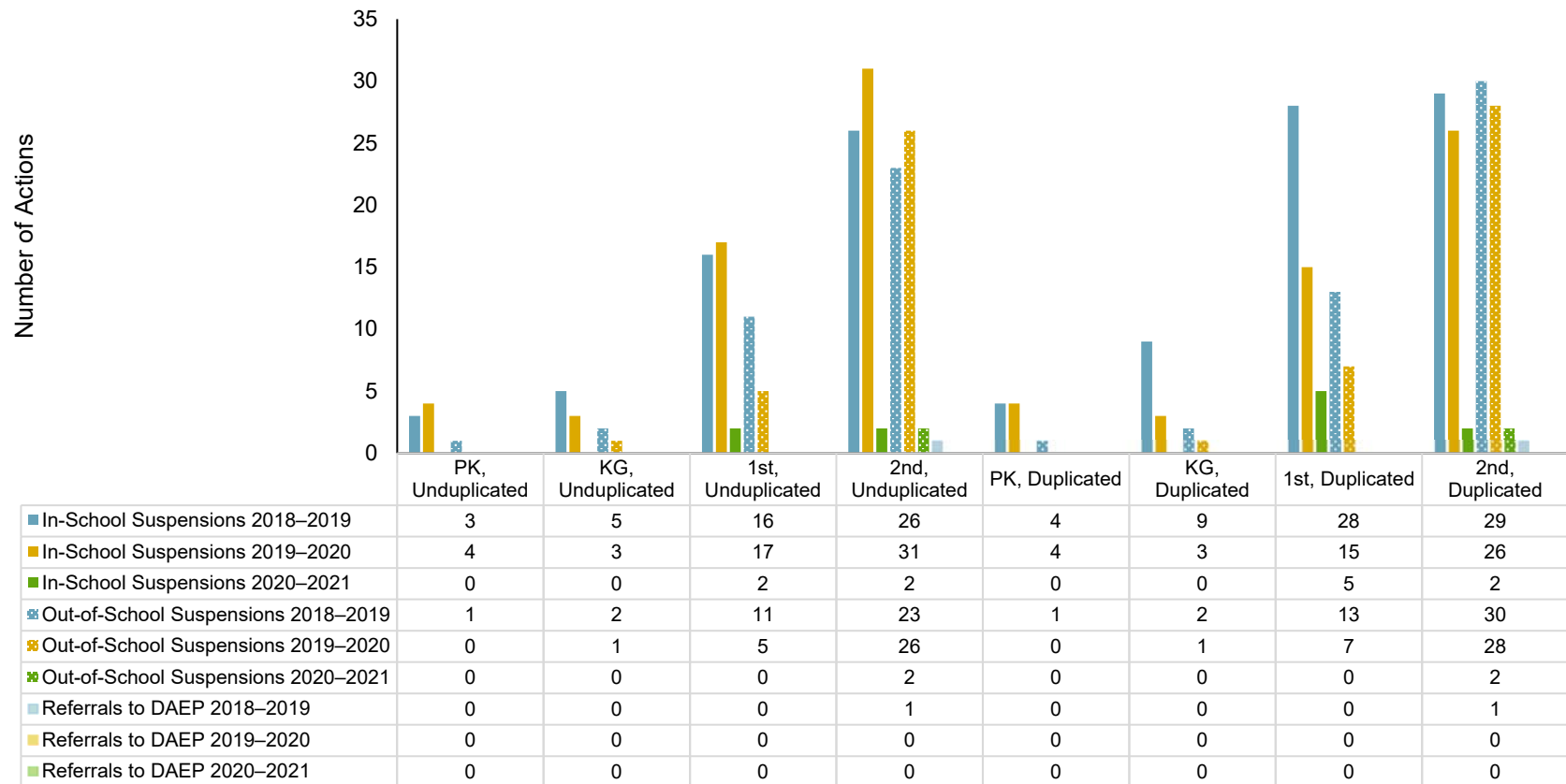

- In 2020–2021, there were only three expulsions to JJAEP.

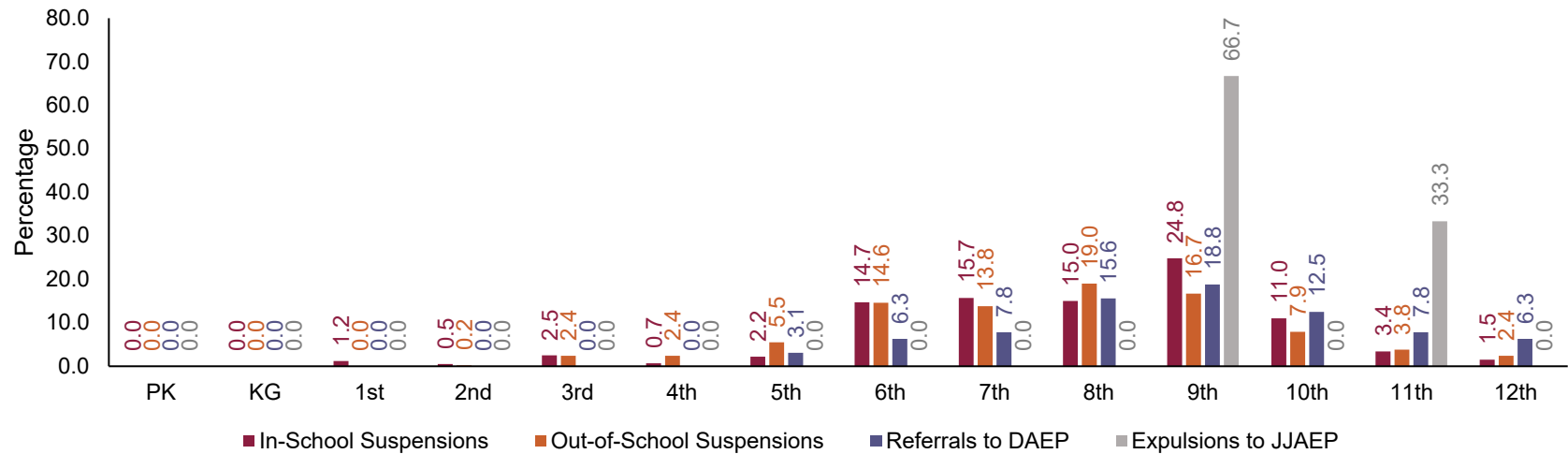
Figure 2 (p. 7) shows the unduplicated and duplicated counts of disciplinary actions for students in PK through 2nd grade. Per board policy FO(LOCAL), “Beginning with the 2016–17 school year, no student shall be informally sent home. No student prior to third grade shall be suspended, placed into a disciplinary alternative setting, or expelled, except as required by law.” Systems should be established to monitor, verify, and document that all PK through 2nd grade disciplinary actions taken were legally required.

- In 2020–2021, there were only seven in-school suspensions and two out-of-school suspensions among students in PK through 2nd grade.

Figure 3 (p. 8) shows the proportion of disciplinary actions across grade levels for 2020–2021, and **Table 5** (p. 8) shows the counts. Students in the 9th grade had the largest proportion of in-school suspensions (24.8 percent), 8th grade students had the largest proportion of out-of-school suspensions (19.0 percent), and 9th grade students had the largest proportion of referrals to DAEP (18.8 percent).

Appendix A (pp. 10–12) shows the disciplinary action reason codes and descriptions, and **Appendix B** (pp. 13–66) shows the number of disciplinary action reasons by school office and campus.

Discussion

Prior to the 2020–2021 school year, the number of disciplinary actions seemed to be trending down across action types and for students in PK through 2nd grade. In 2020–2021 for students in PK through 2nd grade, seven received in-school suspension, two received out-of-school suspension, and none were referred to DAEP.

However, students who are male, Black, receive special education services, economically disadvantaged, or considered at risk are still receiving disciplinary actions at a disproportionately higher rate than their peers. This trend should remain a focus for campuses as they seek to provide equitable learning environments for all students.
