## I. School Action Plan

Framework B consist of 5% is Campus Action Plan, 15% is Planning and Professionalism; 35% is Student Achievement; and Quality of Instruction is 45%.

### IV. Distinguished Teacher Review

Mr. Walker informed the committee that for teacher to be rated as distinguished, they are going to have to apply through the Distinguished Teacher Review. Ms. Walker gave a brief overview of the rubric and the process. She provided the staff and committee a few minutes to read through the rubric and jot down any questions for submission to the district.
