#### 3/1/19 Emerson Elementary SDMC Minutes

In attendance: Jara, Guevara, Madison, Cantu (notes taken by) Valle, Dr. Rodriquez

Grade level-Check-In: Mrs. Madison indicated second grade is moving. Ms. Guevarra stated fifth grade is real positive and encouraged with the mock results showing students are well on track to meet their learning goals. Mrs. Jara stated everything is moving and second graders dual language is improving. Mrs. Valle indicated things were okay but she was worried about the high need for counseling services campus wide.

The present committee members also recognized all the positive impact of Emerson's on RTI and the prompt support for students through intervention and other services.

#### 1. Proposed Amendments to TADS

Current: Every teacher observed, 2 of each observation, conference optional

Principal discussed district proposed changes to TADS. District provided power point was shown to committee. FAQ document provided.

- Recognize and Reward effective and Highly effective teachers
- Must qualify i.e. at least 3 years, 1 full year in HISD, effective or highly effective in <u>summative</u> rating + each component + prior year.
- Must still have at least 1 observation, 1 walk through.
- Two Required Conferences. Goal setting and EOY.
- For M-TADS removal evidence from 1 observation, 1 walkthrough required.
- Option to opt in annually 1 observation & walkthrough vs 2 of each
- Implemented 2019-2020 school year

Committee use a show of hands to indicate who agreed.

6 out of the 6 committee members present agreed / 3 not present.
