Welcome/Introduction of Members

Mrs. Adams called the meeting to order at 4:15 pm. Mrs. Adams welcomed everyone to the 1st quarter SDMC meeting for the 2021-2022 school year. The committee members introduced themselves as: Principal, Mrs. Adams, Assistant Administrator, Mrs. Peters, SPED Teacher, Dr. Grover, and TA, and Mrs. Joseph. Community Members, Mr. Bailey and Ms. Smith attended the meeting as well.

Reading of old minutes

Dr. Grover read the old minutes from the 1st quarter meeting of the 2021-2022 school year. The minutes were approved.

New Bell Schedule

A new schedule was implemented prior to the start of the 2nd semester. Ms. Peters said the new schedule allows students to go to 5th or 6th period before going to lunch, and the new procedure has been a success. The students seem to be adjusting well to the new bell schedule.

New Master Schedule

Mrs. Adams said there has not been any changes to the Master Schedule. Next year, we will have HVAC program and a dance teacher.

School Safety

We have implemented a new check-in safety measure at North Forest. The students are waned by a metal detector device every morning before

entering the building. The student's backpacks are also checked before entering the building. Ms. Adams would like to get a walk through metal detector device for future use.

Ms. Adams said field trips have been pushed back because of the current state of COVID-19. She reiterated that the district mask mandate is still in place. Students are given a mask when needed. The tables in the cafeteria are stocked with Lysol wipes and sanitizer. The students have been given water bottles for drinking. This prevents students from using the water fountain orally.

Transformation Cohort

Mrs. Adams stated the parents have received a letter regarding the sunset of Achieve 180. North Forest has been selected to participate in the replacement for A180 which is the Transformation Cohort. She also stated that a needs assessment for our campus will occur on 2/9/2022. HISD is working with a company that will conduct the assessment. The assessment includes speaking with students, staff, teachers and administrators. We will receive information regarding the Transformation Cohort on 2/22/2022.

Additional Staff

North Forest is partnering with HISD to bring a HVAC course to our school. The teacher will be vetted by HCC. We've also been afforded the money to hire a dance teacher. We have yet to find a dance teacher. Therefore, the dance teacher position is still open.

Question/Concerns

The community members gave feedback on the new programs being implemented at North Forest. Ms. Smith is impressed and offered her support. Mr. Bailey encouraged us to keep striving during this difficult time of teaching because of COVID-19.
